I do here by lodged a written complaint against the above
the noted accused person pertaining to the effect that
on 23.07.20 in course of performing traffic duty at
ulaprai more under Matigara PS in order to restrict
unnecessary movement of vehicular traffic for
combating spread of COVID-19 as per order of chief secretary
govt. of WB vide order no hy FW/120 dated 22.03.20 and MHA
order no 40-3/2020 DM-1 (A) dated 24.03.20 found them loitering
riding toto without any valid reason or authority though
order has already been promulgated nationwide in order
to combating the spread of COVID-19. Hence they violated
the said order and I arrested them 4/341(D) Cr. PC after
properly briefing them about ground of arrest and supplied

by the witnesses.
