In producing here with the person namely Munna Sah S/o. Lt. Satrugan Sah of near govt. saw mill, Adarsh Nagar P.S. Siliguri, Dist- Darjeeling along with one black & white colour City Auto which bearing registration no. WB 73A 6779. I do here by lodge a written complaint against the above noted person pertaining to the effect that on 28.06.21 in course of performing traffic duty at Biharmore under Bagdogra P.S. in order to restrict unnecessary movement of vehicle traffic for combating spread of covid-19 as per order of Chief Secretary Govt. of W.B. vide order no- H & F W, 120 dt-22.03.20 & MHP order no- 41-3/2020 OM1(A) dt-24.03.2020 found him loitering riding City Auto without any valid reason or authority though order has already been promulgated nationwide in order to combat the spread of covid-19. Hence he violated the said order and I arrested him u/s-41(b)(c) Cr.P.C. after properly briefing him about the ground of arrest & supplied him memo of arrest. Accordingly I also seized his City Auto after preparing proper seizure list duly arrested by the witnesses & released him on bail & give a zimma his City Auto in zimma nama as per order of superior.
