I, ASI Pradeep Sarkar of New Jalpaiguri Police Station, SPC do hereby lodged this written complaint against the above noted persons to the effect that on 26/06/21 while performing QRT mobile duty in between 18.15 hrs and 20.15 hrs, I along with forces had been to Netaji More area, and found that the above noted persons were gathered there without any reason and found them without wearing mask also making unnecessary gathering at Netaji More area. On being asked the above noted persons stated before me that they were well aware of Govt. order regarding pandemic situation of Covid-19 and wearing of facial mask has been mandatory in public places in the current pandemic disaster situation.

They all are violated the order of Govt. of West Bengal vide Memo No. 486-CS/2021 dt. 24.04.2021. Hence, I arrested them in c/w the case under proper memo of arrest in between 18.15 hrs and 20.15 hrs duly signed by them in presence of witnesses inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation of the case.
