Singh (30 Yrs) S/O Lt. Mahendra Singh of Bhabesh More, PS - NJP, Dist- Jalpaiguri (2) Raju Roy (18 Yrs) S/O Bishu Roy of Bhola More, P.O Sahudangi, PS -NJP, Dist- Jalpaiguri (3) Nishant Kr. Giri (23 Yrs) S/O Anilo Giri of Bhola More, P.O Sahudangi, PS -NJP, Dist- Jalpaiguri were rooming at Saktigarh area, PS -NJP without any reason without wearing face mask. On being asked the above noted persons stated before me that they were well aware of Govt. order regarding pandemic situation of Covid-19 and wearing of facial mask has been mandatory in public places in the current pandemic disaster situation. Accordingly they were arrested U/s 41 Cr.P.C for violating Govt. order regarding pandemic situation, I SI took up the investigation of the case.
