Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Dakshin Ektlasal area as indicated by my source I held raid at the house Subhash Barman at Dakshin Ektiasal But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles, I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 18.25 hrs and 18.45 hrs on
