In producing herewith one accused person namely Shyamraj Saibya(42) S/O Lt Mohidas Saibya of Sarajini Pally, Sweeming Poll, W/N-42, PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Sixteen(16) Pouch of Officer's Choice Delux Whisky(each pouch containing 180ML).
2. Two (02) Pouch of McDowell's no-1 Celebration Matured XXX Rum (each Pouch of containing 180 ML).
3. Twelve(12) Bottles of TUBORG Premium Beer Strong (each bottle containing 650 ML).

I, SI Sibdhan Karmakar of Bhaktinagar PS, SPC lodged a written complainant against the above noted person to the effect that today i.e. on 26.06.2021 at 22.25 hrs received a source information that one person has stored huge amount of liquor at Sarajini Pally, Swimming Pul, W/N-42, PS- Bhaktinagar Dist- Jalpaiguri for selling the same to his design customer for his wrongful gain in his house. This refers to Bhaktinagar PS GDE No-1654 Dated 26.06.2021. Accordingly I informed the fact to I/C Bhaktinagar P.S. As per his kind instruction I along with ASI Biswajit Saha ,CV-935 Biplab Roy, CV-614 Sumit Roy proceeded to Sarajini Pally, Sweeming Poll, W/N-42, PS- Bhaktinagar Dist- Jalpaiguri to work out the information. At 22.35 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of Shyamraj Saibya ,Sarajini Pally, Sweeming Poll, W/N-42, PS- Bhaktinagar and recovered the above noted articles from the possession of above noted accused person namely Shyamraj Saibya(42). On demand he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt before us and stated that he sells the same in the customer since long for his wrongful gain. In presence of witnesses namely Dipak Biswas s/o Lt. Gopal Biswas of Limbu Busty, Prakash Nagar, w/n-42, PS - Bhaktinagar, Dist- Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 22.55 hrs to 23.35 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person namely Shyamraj Saibya(42) S/O Lt Mohidas Saibya of Sarajini Pally, Sweeming Poll, W/N-42, PS- Bhaktinagar Dist- Jalpaiguri under proper section of law.
