At 22.35 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at the house of Shyamraj Saibya ,Sarajini Pally, Sweeming Poll, W/N-42, PS- Bhaktinagar and recovered the above noted articles from the possession of above noted accused person namely Shyamraj Saibya(42). On demand he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt before us and stated that he sells the same in the customer since long for his wrongful gain. In presence of witnesses namely Dipak Biswas s/o Lt. Gopal Biswas of Limbu Busty, Prakash Nagar, w/n-42, PS - Bhaktinagar, Dist.-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 22.55 hrs to 23,35 hrs. I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.
