With due respect I, **SMT. ALATI ROY**, W/O Sri Rabi Roy, resident of Old Battala, Ektiasal, Ward. No. 40, P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri, would like to lodge this written complaint to the effect that on last day i.e. on 26.06.2021 my neighbor namely Sri Sajen Roy, S/o Shani Roy residing at Old Battala, Ektiasal, Ward. No. 40, P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri came to my house and took my husband accompanying with him at Shikarpur Hat for purchasing Goat for a customary rituals. That the said person came back to his house by leaving my husband alone at Shikarpur Hat for some reason best known to him and at about 09:00 PM the said person came to my house without any just cause and reason started abusing me and my daughter with very filthy and abusive languages and assaulted me and my daughter with fists and blows and touched my private parts by tearing my wearing apparels and the person did not stopped here moreover he go outside my house and he damaged my

shop and its table and he took away Rs. 700/- (Rupees Seven Hundred) Only and at the same time the other neighbors came and rescued us from the said person and he further threatened me that he will kill me, my daughter and husband very soon as he is a influential person of the area and no one can stop him from doing that.

Moreover, the said person deals in illegal liquor in the locality and he has no fear of Law.

I, therefore, request you to register this complaint as FIR and please take necessary legal steps against said Sri Sajen Roy as per the provisions of law and obliged thereby.
