Sir,

In producing herewith one seized vehicle having Registration No WB/73D-9804 loaded with small stone along with original seizure list and do hereby lodged this complaint against the driver of above noted seized vehicle.

I ASI Ratan Kr Ghosh of Panitanki TOP under Siliguri PS, SPC lodge this written complaint against the driver of vehicle having Registration No WB/73D-9804 (HGV/Dumper) to the effect that, on 22/06/21 I along with CV/1007 Jiten Roy, CV 1009 Manoj Thakur and the were performing night Mobile van duty vide Panitanki TOP MCC No 1019 Dated 22/06/21. In course of my mobile van duty today on 23/06/21 at 07:05 hrs I received information from my source that, one truck loaded with small stone is coming from Odlabari side towards Panjabipara side under Panitanki TOP area via Ashighor without any valid document. Accordingly I informed the matter to O/C Panitanki TOP over telephone and as per his direction, I along with force reached at Panjabipara near Pronami Mandir today on 23.06.21 at 07:15 hrs to verify the veracity of information and found that one track (Dumper) having Registration No WB/73D-9804 loaded with stone is coming from Ashighor side. Seeing the Police party, the driver of said track stopped his vehicle beside road and flees away. Then in presence of witnesses I searched the royalty/or documents of loaded stone in the vehicle but in vain. Under the above circumstances there is sufficient reason to believe that, the driver of above noted vehicle have stolen this stone from Odlabari side without any legal royalty/papers as per rule, for selling clandestinely. Accordingly, I seized the said vehicle having Registration No WB/73D-9804 loaded with stone under proper seizure list duly signed by witnesses. The search and seizure and arrest were made in between 07.20 hrs and 07.45 am on 23/06/21.

Under the above circumstance I pray before you that a specific case may kindly be started against the driver of above noted seized vehicle and arrange for its investigation.
