In producing here with 04 (four) arrested accused persons who disclosed their identity as 1) Bimal Shil (40) yrs, S/O-Sumanta Shil of 2 No, Jyotinagar, ward No-4, P.S-Siliguri, Dist. Darjeeling, 2) Md. Alauddin(45) yrs. S/O-Late Md. Sofijuddin of Rabvita, near Pry. School, P.S-Phansidewa, Dist. Darjeeling, 3) Hriday Shil (33) yrs. S/O-Late-Suresh Chandra Shil of Fatapukur, near Petrol Pump, P.S-Rajganj, Dist. Jalpaiguri, and 4) Mahesh Tiwary (55) yrs. S/O-Late Mohan Tiwary of Jyotinagar colony, ward No-4, P.S-Siliguri, SPC, all the above noted accused persons arrested proper memo of arrest, in c/w above noted case reference.


I, SI. Upendra Nath Roy of Khalpara TOP under Siliguri PS, SPC, do hereby lodge complaint against the above noted arrested persons, to the effect that on 23-06-21 at 13.05 hrs, myself along with force while performing Special mobile van duty at Jhankar More, Siliguri area, Vide Khalpara TOP-II, GDE No-783/21 dated 23.06.21 and found that the above noted persons had made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, and Order No-647-ISS/2M-22/2020 DATED 15-05-21. wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19 .. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security and as per order of I/C Siliguri P.S, and O/C Khalpara TOP-II, I released the above noted accused persons.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
