In producing herewith the 05 (Five) accused persons namely (1) Palash Saha (35) S/O - Parikshit Saha of Janata Nagar, Ward No 44, PS Bhakti Nagar, Dist Jalpaiguri, (2) Harbindar Singh (52) S/O Late Sawran Singh of Haidarpara, Buddha Mandir Road, Ward No-40, PS Bhakti Nagar, Jalpaiguri (3) Totan Saha (19) S/O Pintu Saha of Ashrampara, (Near Sarba Mangala Kali Mandir) Ward-13, PS Siliguri Darjeeling (4) Mukesh Singh (35) S/O Late Badam Singh of Do and (5) Anil Das (40) S/O Late Sunil Das of Vidya Chakra Colony, Ward No 44, PS Bhakti Nagar, Jalpaiguri along with the following seized articles with seizure list;

I, SI Rana Ibrahim of Panitanki TOP under Siliguri PS lodged a written complaint against the above noted accused persons to the effect that today on 23.06.2021 I along with C/114 Naresh Hasda and C/702 Lahir Rahman were performing evening mobile van duty vide MCC No-1024 dated 23/06/21 and at 14:35 hrs I received information that an Online-gambling (LOTO) is going on at Jala Lalpath Roy Road, Ashrampara under Panitanki TOP inside a shop of Palash Saha S/O - Parikshit Saha of Janata Nagar, Ward No 44, PS Bhakti Nagar, Dist Jalpaiguri. Accordingly I informed the matter to O/C Panitanki TOP and as per his kind direction myself along with above noted force as well as SI Ashim Kr Das, ASI Biswajit Ghosh, Const- 576 Binoy Ch Roy and C/233 Nagen Ch Barman all are of Panitanki TOP left for the spot to verify the veracity of information. On arrived at 14:50 hrs at the spot found that the above noted accused persons are engaged in online gambling (LOTO) with the help of Computer with a view to wrongful gain and wrongful loss to each other's by cash & online transaction. On seeing the police party they try to flee away from the spot but on hot chased police party apprehended the above noted accused persons namely (1) Palash Saha (35) S/O - Parikshit Saha of Janata Nagar, Ward No 44, PS Bhakti Nagar, Dist Jalpaiguri, (2) Harbindar Singh (52) S/O Late Sawran Singh of Haidarpara, Buddha Mandir Road, Ward No-40, PS Bhakti Nagar, Jalpaiguri (3) Totan Saha (19) S/O Pintu Saha of Ashrampara, (Near Sarba Mangala Kali Mandir) Ward-13, PS Siliguri Darjeeling (4) Mukesh Singh (35) S/O Late Badam Singh of Do and (5) Anil Das (40) S/O Late Sunil Das of Vidya Chakra Colony, Ward No 44, PS Bhakti Nagar, Jalpaiguri. Accordingly in presence of independent witnesses I searched the above noted accused persons and found the following articles from their possession which I seized under proper seizure list as they failed to produce any valid licence for their this type of gambling. The search and seizure was made in between 15:00 hrs to 15:55 hrs.

In this circumstances it is clear that, the above noted accused persons namely (1) Palash Saha (35) S/O - Parikshit Saha of Janata Nagar, Ward No 44, PS Bhakti Nagar, Dist Jalpaiguri, (2) Harbindar Singh (52) S/O Late Sawran Singh of Haidarpara, Buddha Mandir Road, Ward No-40, PS Bhakti Nagar, Jalpaiguri (3) Totan Saha (19) S/O Pintu Saha of Ashrampara, (Near Sarba Mangala Kali Mandir) Ward-13, PS Siliguri Darjeeling (4) Mukesh Singh (35) S/O Late Badam Singh of Do and (5) Anil Das (40) S/O Late Sunil Das of Vidya Chakra Colony, Ward No-44, PS Bhakti Nagar, Jalpaiguri violated the provision of W.B.G & P.C Act. Accordingly I arrested them issuing proper memo of arrest.

Hence I pray before you that a specific case may kindly be started against the above noted accused persons under proper section of Law and arrange for its investigation.
