- Vijay Anand Prasad, son of Shri.Rajendra Prasad, advocate by profession, resident of 'Neel Kamal', Vivekananda Road, Khalpara, Siliguri 734005, District Darjeeling in the state of West Bengal do hereby state as follows:-
 - That the Title Suit No.245 of 2019 being Vijay Anand Prasad and another v/s Sudhir Ghosh and two others is pending before the Ld.Civil Judge (Junior Division) at Siliguri.
 - 2) That in the above stated suit the Ld.Court was pleased enough to allow the ad interim prayer made by the Plaintiff's (i.e. myself) thereby restraining the Defendants (i.e. Sudhir Ghosh, Mamata Ghosh and Sonu Ghosh) from trespassing upon the suit scheduled property.
 - 3) That 08th day of February 2021 was fixed for injunction hearing by the Ld.Court wherein all the Defendants of the above mentioned suit number failed to appear before the Ld.Court inspite of service of the notice/summons upon the Defendants and the Ld Court was pleased to pass an order by disposing the ad-interim injunction petition and by making the same absolute by restraining the Defendants from interfering,

trespassing, encroaching of the suit schedule property which is bounded by the boundary wall.

- 4) That today morning while I had been to the suit scheduled land situated and comprised at Mouza: Siliguri, Touzi No.3, J.L. No.110 being Plot/Dag No. 2506 (Part), Khatian Nos. 2058, 2059 and 2049, Paragana: Baikunthapur, PS: Siliguri, District: Darjeeling; I was surprised to note down that the defendants were trespassing over the suit scheduled property and thus violating the order of the injunction which has been allowed by the Ld.Court.

No.110(88), Touzi 3(Ja), Paragana Baikunthapur, Vidyasagar Pally Road, Ghoshpara, Ward No.07 (seven) of Siliguri Municipal Corporation, Siliguri 734005, P.O. Siliguri Bazar, P.S. Siliguri, District. Darjeeling, in the state of West Bengal, by violating the building plan approved by Siliguri Municipal Corporation in the year 2009 and have let out the same to her tenant/s for running goods transport business cum godown and in this course the above named Sonu Ghosh and Mamata Ghosh together with her tenant/s are also violating the order of injunction passed by the Ld Court, be it noted that the said

tenant/s are also aware and acquainted of the injunction order passed by the Ld.Court.

6) That a petition under section 151 of the C.P.C. was moved before the court of the Ld.Civil Judge (Junior Division) dated 08th day of April 2021 by the Plaintiffs (i.e. myself) of the above referred case number wherein the Ld Court passed an order directing the Inspector-in-Charge of Siliguri Police Station (Khalpara Town Out Post) towards its (order of injunction) implementation in letters and spirit.

Under the above facts and circumstances it is hereby prayed before your goodself to enquire into the matter and take necessary action against the above named wrongdoers and also to restrain them from violating the order of the Ld.Court.
