- 2) **Sachin Rai** (M-46yrs) S/O-H.B. Rai of Navin Gram, Gandhi Road, Darjeeling, West Bengal, 734101, riding one white coloured four wheeler Maruti Wagon vehicle bearing Registration No. WB 76 A 8260.
- 3) **Ravi Singh Rai** (M-35yrs) S/O-Amar Rai of Sumripani Top Line, Samrik Tea Garden (Simripani), Darjeeling, 734216, riding one four wheeler Maruti Omni Van bearing Registration No. WB 74 AA 0523.
- 4) **Utpal Pal** (M-32yrs) S/O-Baidyanath Pal of Ratan Lal Pally, Bhimbarnadati, Siliguri, Darjeeling, 734101, riding one white coloured four wheeler Honda City bearing Registration No. WB 74 AJ 1200
- 5) **Krishna Kumar Barman** (M-54yrs) S/O-Dasulal Barman of Deshbandhu Para, Girija Apartment, Siliguri, riding one white coloured four wheeler Maruti Ertiga bearing Registration No. WB 66 AJ 0022
- 6) **Naren Barman** (M-46yrs) S/O-Nalit Barman of Shaktigarh, Ward No. 33, Siliguri, riding one TOTO bearing Number WB 73F7178.

I, SI Dinesh Chandra Barman of Panitanki Traffic, SPC Guard, SPC do hereby lodge complaint against the above noted arrested persons to the effect that on 25.06.2021 during the course of performing my regular Traffic Regulation Duty at Airview More in between 18:00 hrs to 23:50 hrs found the above noted persons were roaming without wearing Mask on their face and without any proper reason with their respective vehicles.

On being asked, the above persons stated before me that they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and valid movement pass issued by the local police authority or civil administration.

Hence they violated the order of Govt. of West Bengal duly promulgated in Order No. 160/C, dated. 22.07.2020 and Order No. 647-ISS/2M-22/2020 dated-15/05/2021, Order No. 713-ISS/2M-22/2020, dated. 31.05.2021 and Order No. 753-ISS/2M-22/2020, dated. 14.06.2021. The above noted person intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of breakout of pandemic COVID-19 throughout the country. Accordingly I seized the above noted vehicles and arrested them under section 41 Cr.P.C. in c/w the case after observing all rules and formalities.

Hence, I request you for starting a case under section 188/269/270 IPC r/w section 51 (b) of Disaster management Act 2005 against the above noted arrested accused person and arrange proper investigation of the case.
