Sir,

I, SI Hiru Kanti Sarkar of Siliguri P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against namely; (1) Gulam Mustafa @ Chota Kalu (30) S/O Late Md. Lal of Darbhangatola, Vivekannanda Road, Ward No. 06, PS- Siliguri Dist- Darjeeling (2) Maherul SK @ Raja (19) S/O Rabbul Sk of Baishtamtola, Durgaour, PS- Itahar, Dist- Uttar Dinajpur, A/P Tikiapara Matangini-II, Ward No. 28, PS- Siliguri, Dist- Darjeeling, (3) Goutam Banik (36) S/O Sri Gopal Banik of Rabindra Nagar, Satinathdas Sarany, Ward No. 21, PS-Siliguri, Dist- Darjeeling (4) Badal Rangder (28) S/O Rambilash Rangder of Rana Busty, Ward No. 28, PS- Siliguri, Dist- Darjeeling under arrest along with following seizure articles; (i) One (01) knife measuring approx. 14" including handle recovered from the possession of Gulam Mustafa @ Chota Kalu (knife was on his hand) (ii) One iron rod measuring approx. 30" pointed at one end (seemed to be implement of house breaking) recovered from Maherul SK @ Raja, (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its handle recovered from the possession of Goutam Banik which he was holding on his hand and (iv) One Sword measuring approx 26 "including handle recovered from the possession of Badal Rangder.

In this regard, I beg to report that on 27.06.21 at 02:35 hrs received secret reliable source information that about 10/12 anti socials armed with deadly weapons assembled at Jorapani Bridge under Siliguri PS for making preparation to commit dacoity at Dakshin Bharat Nagar area. I informed this source information to IC Siliguri PS and noted the information vide Siliguri PS GDE No. 1653 Dated 27.06.21. As per the direction of IC Siliguri PS, at 02.45 hrs, I along with ASI Siben Sarkar, ASI Subir Sen, CV/283 Prosenjit Dey, CV-622 Ramanath Barman left for working out the information vide Siliguri PS GDE No. 1654Dtd. 27.06.21 after briefing officers and force properly and also along with required papers / articles. At 02.55 around hrs we reached at Jorapani bridge and kept our vehicle at considerable distance. Then, I along with Officers and force headed towards Jorapani bridge looking for witnesses, if any on the way and found nothing. By this time we reached Jorapani bridge, as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted four persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names

and address as noted above and admitted that they along with 9/10 others assembled at the spot making preparation to commit dacoity tonight at Dakshin Bharat area. I accordingly searched them in presence of witnesses and found ((i) One (01) knife measuring approx. 14" including handle recovered from the possession of Gulam Mustafa @ Chota Kalu (knife was on his hand) (ii) One iron rod measuring approx. 30" pointed at one end (seemed to be implement of house breaking) recovered from Maherul SK @ Raja, (iii) One Dao (Sharp Cutting weapon) measuring approx. 18" including its handle recovered from the possession of Goutam Banik which he was holding on his hand and (iv) One Sword measuring approx 26 "including handle recovered from the possession of Badal Rangder were making preparation for committing Dacoity tonight in Dakshin Bharat Nagar area but others managed to escape. Accordingly, I seized above noted weapons in presence of above mentioned witness under proper seizure list duly signed by them and labeled the same and arrested them informing them their ground of arrest preparing memo of arrest. The seizure and label was made in between 02.45 hrs to 03.45 hrs of dated 27.06.21.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity at nearby Dakshin Bharat Nagar area.

Further, it to mention here that the arrested accused persons are well known anti socials and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against them and 7/9 others who fled away under proper section of law and to cause its investigation.
