Sir,

In producing herewith five (05) arrested accused persons who disclosed their names as as (i) Pranay Kundu (25yrs) S/O- Pradip Kundu of South Santinagar, near Housing Complex, PS-Bhaktinagar, Dist-Jalpaiguri, (ii) Milan Roy (26yrs) S/O- Akhil Ch. Roy of Vill +PO- Barakamat, PS-Mainaguri, Dist-Jalpaiguri A/P- Nitish Dey of 1 No Dabgram Colony, Ward No-23, PS-Siliguri, Dist-Darjeeling, (iii) Deepak Goswami (30yrs) S/O- Lt. Munna Goswami of Subash Nagar, Islampur, PS-Islampur, Dist-Uttar Dinajpur, A/P- Fulbari, Seventy More, PS-NJP, Dist-Jalpaiguri, (iv) Md. Mahid (38yrs) S/O- Md. Mohin of Howrah Petrol Pump, Burdwan Road, PS-Siliguri, Dist-Darjeeling & (v) Chhotan Saha (37yrs) S/O- Lt. Hiralal Saha of Bhaktinagar, near Central Bank, PS-NJP, Dist-Jalpaiguri alongwith one Toto deep green colour without number. I, PSI Rajiv Subba of Siliguri PS/SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 29.06.2021 at 20.05 hrs during my Mobile Van duty myself alongwith my accompanied force had been to Dabgram area, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons. one of them namely Chhoton Saha was roaming with there with his TOTOs noted above.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and without valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021 and Order no.753-ISS/2M-22/2020 dt.14.06.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the country. Accourding, I seized the above noted TOTO under proper seizure list and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
