With due respect, I Sri Paritosh Sarkar, S/o Sri Narayan Sarkar, resident of Patiram Jote, BT Randip Colony, P.O & P.S.-Matigara, District - Darjeeling, would like to inform you that on 7 - 12 - 2015, marriage of my daughter namely Purnima Sarkar (Saha) was solemnized with one Gopal Saha, S/o Sri Paresh Saha, resident of Telipara, Ashighar, P.O.-Ashighar, P.S.-Bhaktinagar, Dist-Jalpaiguri at my house at aforesaid address according to Hindu rites and customs. After marriage, the said Purnima Sarkar (Saha) has started her conjugal life with the said Gopal Saha alongwith her in-laws at her matrimonial house at Telipara. Ashighar, After few days of marriage, the said Gopal Saha alongwith his father namely Paresh Saha, mother namely Archana Saha, brothers namely Ashok Saha and his wife Pinki Saha and Gobinda Saha. Sisters-in-law namely Tultuli Saha and her husband Pintu Saha and Bulbuli Saha and her husband Santosh Saha have started to demand dowry and have started their mental and physical torture upon my daughter and abuse her in filthy languages, not only that on several occasions, the above named persons have assaulted my daughter without any authentic reasons and day by day their torture increases. In the mean time, my daughter has delivered a female child namely Preyoshi Saha. On several time, the above named persons are trying to kill my daughter by hanging her but any how she managed to save her life. Not only that on several time, the above named persons are trying to oust my daughter from hermatrimonial house and my daughter bound to spent her nights alongwith her child out side of her matrimonial house. On 14-6-2021 my daughter alongwith her husband Gopal Saha came at my house for celebrating the jamai shoshti which held on 16-06-2021 and on the next day i.e. 17 - 6 - 21, the said Gopal Saha without any authentic reasons tortured my daughter in presence of me and my family members and thereafter the said Gopal Saha had been to his parental house without our knowledge by leaving my daughter at my house. On 27-06-2021 the said Gopal Saha came at my house and brought my daughter at his parental house. On 28-06-2021 in the evening, the above named persons alongwith son of Bulbuli saha namely Akash Saha, brother-in-law of Bulbuli Saha namely Bishnu Saha and her Sister-in-law Sandhya Saha (Jaa) and Buli Karmakar (Nanad) all are resident of Sitala Para. Jalpaimore. on the issue of quarrel, have mercilessly assaulted my daughter physically causing she sustained internal injuries and after having said information. I alongwith my family members and some local people had been to matrimonial house of my daughter by Toto and after reaching there, we find that

the above named persons were miserably assaulting my daughter with intention kill my daughter and when we tried to save my daughter, they also assaulted us by iron rod and attacked my son Pralad Sarkar by sharp knife and attacked me by iron rod on my head, not only that they are also damage our hired 2 numbers of toto. Due to assault, 1 fell down on the ground and became senseless and others are sustained severe injuries on their body. After having of said incident, nearby police officials came and save our life. Thereafter local people brought us alongwith my daughter to Siliguri Sadar Hospital for treatment and my daughter is hospitalised and till now she is fighting with her life. Since 28 - 6 - 2021 my daughter is sighting for her life and death.

So, requesting you to investigate the matter and take necessary legal action against the offenders.

I was seriously busy in the treatment of myself and my son alongiwth my daughter. I could not lodge my complaint within time. So I may be excused.
