In producing herewith one accused person namely Smt Shipra Das (26), D/O- Dilip Das of Naresh More Papia Para PS Bhaktinagar Dist Jalpaiguri and the following articles under seizure:

(1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total-9 Liter & Amount Rs 1500/-)

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Smit Shipra Das (26), D/O- Dilip Das of Naresh More Papia Para PS Bhaktinagar Dist Jalpaiguri to the effect that. on 02.07.2021 evening as per order of O/C Ashighar OP I along with ASI Sumit Baran Nath C/877 Management Ahamed, L/C 1234 Hira Roy and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle at WE42 E 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigarh OP as per order vide Ashighar OP GDE no. 30 Dt 02.07.2021 in course of which I received information from my source that one Shipra Das stored a huge numbers of bottles liquor inside her house at Naresh More Papia Para and used to sell to the local youth in higher rates. I immediately informed 3 C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Named More Papia Para area to verify the veracity of information. On the way I called two local person namely [1] Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinager Dist Jalpaiguri and [2] Alay Sarkar (31) S/O Sunii Sarkar of Niranjan Nager w/no 36 PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Naresh More Papia Para area as indicated by my source I held raid at the house Shipra Das at Naresh More Papia Para . But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend her. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside her house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 14.15 hrs and 14.35 hrs on 02.07.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Smt Shipra Das (26), D/O- Dilip Das of Naresh More Papia Para PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
