In producing herewith one accused person namely Rampukar Prasad (60) S/O: Late Sripujan Prasad of Prokashnagar near Adarsh School PS- Bhaktinagar Dist- Jalpaiguri along with the following seized articles as per proper seizure lists as per proper seizure list:

[1] 04 (four) bottles of black lebel Strong Premium beer each bottle containing 650 ml. [2] 06 (six) bottles of Himalayan gold 60up country spirit each bottle containing 600 Mi.

[3] 06(six) bottles of Himalayan gold 60up country spirit each bottle containing 300 Ml.

[4] 04 (four) pouch pack Officer Choice Delux Whisky each pouch pack containing 180 Ml.

[5] 06 (six) bottles of MC Dowell's No-1 Celebration Rum each bottle containing 180 ml.

I, SI Sibdhan Karmakar of Bhaktinagar PS, under Siliguri Pilice Commissionerate lodged this written complainant against one Rampukar Prasad(60) S/O- Late Sri Pujan Prasad of Prokashnagar near Adarsh School PS- Bhaktinagar Dist- Jalpaiguri to the effect that today i.e. on 03.07.2021 at 21.35 hrs received a source information that one person has stored huge quantity of illicit liquor at his Hotel name and Style as Sahuji Hotel situated at Prokashnagar in order to sale the same to his design customers illegally for his wrongful gain. Accordingly I diarized the fact vide Bhaktinagar P.S. G.D.E No- 161 date 03/07/2021 and informed the matter to I/C Bhaktinagar Police Station. As per his kind instruction I along with ASI Biplab Kumar Das, ASI Rabin Lama, CV-14 Labanyamoy Barman and CVF/ 619 Dharmendra Roy left for Prokashnagar to verify the veracity of the information. At 21:55 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Sahuji Hotel and recovered the above noted articles from the possession of above noted accused person namely Rampukar Prasad(60) S/O- Late Sri Pujan Prasad of Prokashnagar near Adarsh School PS- Bhaktinagar Dist- Jalpaiguri .On demand he could not produce any valid license/documents in support of said liquor. He became nervous and admitted his guilt and made in coherent statement before us and stated that he sells the same to the customer since last few months for wrongful gain. Accordingly in presence of witnesses I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 22.15 hrs to 22.45 hrs. As the accused person violated rules and norms of Bengal Excise act as such, I arrested the said accused person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you a specific case may kindly be started against the accused person Rampukar Prasad(60) S/O- Late Sri Pujan Prasad of Prokashnagar near Adarsh School PS- Bhaktinagar Dist- Jalpaiguri and his owner under proper section of law.
