2. 12 (Twelve) bottles of 60 up Himalayan Gold of Country Spirit containing 300 ml in each bottle of MRP Rs 50/- of each bottle.

3. 03 (Three) numbers of paper made pouch of Officer Choice Deluxe Whisky containing 180 ml in each pouch of MRP Rs 140/- in each pouch.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 04.07.21 at 18.25 hrs I received a secret source information that one person namely Sital Sarkar of Ambika Nagar, Nichpara, Road No-02, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his residence at Ambika Nagar under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 192 dated 04.07.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das, ASI Khagen Barman, C/1053 Paresh Rava, CV/824 Niru Kumar Yadav left for Ambika Nagar to work out the information in hand. At about 18.25 hrs we arrived at Ambika Nagar and being shown and identified by the source we held raid at the house of Sital Sarkar of Ambika nagar and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his wrongful gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his residence.
