I, Raj Kumar Ghosh, Inspector of Police, Detective Department, Siliguri Police Commissionerate, do hereby lodge this written complaint against the aforesaid eight accused persons namely (1) Mani Pal (66 Yrs.) S/o. Lt. Manik Lal Pal of Bidhan Road, Post.+P.S. – Siliguri, Dist.- Darjeeling, (2) Suhan Roy (31Yrs.) S/o. Lt. Nirmal Roy of Vill.- Jorepakhri, Post.+ P.S. Mayanaguri, Dist.- Jalpaiguri, (3) Sajal Chakraborty (40Yrs.) S/o. Subrata Chakraborty of Saheb Bagan, Station Road, Bhadreswar, Post.+P.S. Bhadreswar, Dist.- Hoogly, (4) Sudip Chakraborty (41Yrs.) S/o. Lt. Ratan Chakraborty of Bishpara, Raghunathpur, Post.- Naya Sarai P.S. –Mogra, Dist.- Hoogly, (5) Prasanta Sarkar (42 Yrs.) S/o. Lt. Sambhu Sarkar of Government Colony, Station Road, Bhadreswar, Post.+P.S. Bhadreswar, Dist.- Hoogly, (6) Shamik Chatterjee (40 Yrs.) S/o. Lt. Shyamal Chatterjee of Chandan Nagar (near Post Office) Post.+ P.S. Chandan Nagar, Dist. – Hoogly, (7) Anil Singh (28 Yrs.) S/o. Ghantakar, Dist.- Dharwad (Karnataka) to the effect that on 03/07/2021 at 06.05 hrs received a secret information over telephone at DD Office, Siliguri, Siliguri Police Commissionerate from a reliable source that some prostitution business is going on at "THE HOTEL EMPEES" Bidhan road, P.S. Siliguri for wrongful gain of money under coverage of hotel business. Accordingly the information was diarized at Detective Department, vide DD SPC GDE no. 05 Dated 03/07/2021 and the matter was also informed to superior officer of DD. Accordingly myself along with SI Mrityunjoy Roy, SI Swadesh Sasha, SI Biswajit Ghosh, ASI Abu Taleb, Const.- 945 Krishna Barman, Const.- 932 Pabitra Das, Const.-562 Utpal Saha, L/C 1310- Dipika Thapa & L/C 331 Kalpana Chhetri all of DD, SPC left for "THE HOTEL EMPEES" Bidhan road, Siliguri. On way we picked up two independent witnesses namely (1) Jogesh Mahanta @ Rubai S/o. Jagadish Mahanta of Thiknikata, P.S. Matigara, Dist Darjeeling & (2) Sonu Agarwal S/o. Krishna Kumar Agarwal of Nehru Road, Khal Para, Ward No. 7, P.S. Siliguri from Bidhan Road near Venus More and requested them to remain present during the time of raid, search & seizure, if any. Subsequently we entered into the hotel styled as "THE HOTEL EMPEES" and found one male person at the reception counter, on being asked he disclosed his identity as Suhan Roy (31Yrs.) S/o. Lt. Nirmal Roy of Vill.- Jorepakhri, Post.+ P.S. Mayanaguri, Dist.- Jalpaiguri, attending staff of "THE HOTEL EMPEES" and further, on search,

we found another person, who has been identified by the said Suhan Roy, as the owner of the hotel and gave his identity as Mani Pal (66 Yrs.) S/o. Manik Lal Pal of Bidhan Road, Post.+P.S. – Siliguri, Dist.- Darjeeling, we then detained them and gave our identity of each and everybody of us and also requested them to assist in the process of search/seizure. The said Mani Pal & Suhan Roy then guided us in presences of the aforesaid independent witnesses (1) Jogesh Mahanta @ Rubai S/o. Jagadish Mahanta of Thiknikata, P.S. Matigara, Dist Darjeeling & (2) Sonu Agarwal S/o. Krishna Kumar Agarwal of Nehru Road, Khal Para, Ward No. 7, P.S. Siliguri as noted above and opened the rooms as 2<sup>nd</sup> floor and knocked the doors at different rooms and there we found that aforesaid accused (1) Sajal Chakraborty (40Yrs.) S/o. Subrata Chakraborty of Station Road, Bhadreswar, Post.+P.S. Bhadreswar, Dist.- Hoogly, (2) Sudip Chakraborty (41Yrs.) S/o. Lt. Ratan Chakraborty of Raghunathpur Kuntighat, Post.- Naya Sarai P.S. –Mogra, Dist.- Hoogly, (3) Prasanta Sarkar (42 Yrs.) S/o. Sambhu Sarkar of Bhadreswar, Post.+P.S. Bhadreswar, Dist.- Hoogly, (4) Saumik Chatterjee (40 Yrs.) S/o. Lt. Shyamal Chatterjee of Chandan Nagar Post.+ P.S. Chandan Nagar, Dist. – Hoogly, (5) Anil Singh (28 Yrs.) S/o. Shankar Singh Of Bahadurganj, Post.+ P.S. - Bahadurganj, Dist.- Kishanganj (Bihar) & (6) Gajendra Trojaram Kolapur (46 Yrs.) S/o. Trojaram Kolapur Of Golabagh, Post.+ P.S. Golabagh, Dist.- Purnia (Bihar) are with the six victim girls in three different rooms at the 2<sup>nd</sup> floors in objectionable condition ( almost totally undressed condition) and were likely engaged in sexual activities. There after with the help of the lady police personnel, we separated the female persons from the male persons and on being asked the female persons disclosed their identity as (1) Tanusree Bhowmik ( 31 Yrs.) D/o. Bijan Bhowmik of vill.- Kshudirampally, P.S. Islampur, Dist.- Uttar Dianjpur, (2) Puja mandal (24 Yrs.) D/o. Sushil Mandal of Srinagar Madhyamgram Chowmatha, P.S. Madhyamgram, Dist. - North 24 Paraganas, (3) Gouri Sarkar (27 Yrs.) D/o. Anil Baidya, W/o. Bappa sarkar Of Vill.- Ghasihara, Post+ P.S. Sonarpur, Dist.- South 24 Paraganas, (4) Anuradha Sarkar (25 Yrs.) D/o. Ananta Sarkar of Vill.- Mathurapur (Ram mati Gopalnagar) P.S.- Mandir Bazar, Dist.- South 24 Paraganas, (5) Rinki Sha (25 Yrs.) D/o. Jagadish Sha (W/o. Bhim Sha) of Vill.- Birpara Lalpool P.S.- Birpara, Dist.- Alipurduar & (6) Renu Singh D/o. Binod Singh (W/o. Anil Kumar Singh) Vill.- Bahadurganj(near Police station), P.S.- Bahadurganj, Dist.- Kishanganj (Bihar). Furthermore the female persons disclosed that they have been engaged in the business of prostitution for the earning of money for the livelihood and has been indulging in the activities of prostitution for the earning of money by the hotel owner of "THE HOTEL EMPEES" namely Mani Pal (66 Yrs.) S/o. Manik Lal Pal of Bidhan Road, Post.+P.S. – Siliguri, Dist.- Darjeeling with assistance of his staff Suhan Roy (31Yrs.) S/o. Lt. Nirmal Roy of Vill.- Jorepakhri, Post.+ P.S. Mayanaguri, Dist.- Jalpaiguri, as noted above. Then we took the aforesaid six girls in safe custody as recovered victims and the male persons disclosed their identities as noted above and also admitted that they use to come at this hotel to enjoy sexual pleasure in lieu of paying money to the owner of the hotel, Mani Pal, as noted above.

On further interrogation, the hotel owner of "THE HOTEL EMPEES", Mani Pal, as noted above, confessed that he has been carrying on the business of prostitution in his said hotel with his staff Suhan Roy, as noted above, for his monetary benefit and to maintain his livelihood and also admitted that they meet the demand of the customers for sexual pleasure on request by providing the aforesaid recovered victims. We then searched the rooms at the 2<sup>nd</sup> floor of "THE HOTEL EMPEES" in presence of the aforesaid independent witnesses and recovered the above noted articles and seized under proper seizure list duly attested by the accused as well as the witnesses arrested the aforesaid eight accused under proper Memo of Arrest, informing them their grounds of arrest and took the

aforesaid six victims as safe custody with proper lady escort/guard and brought them to Siliguri Police Station. The whole process of Raid, Search & Seizure took place between 06.45 Hrs to 07.45 Hrs. on 03/07/2021.

I would therefore request you that a specific case may please be registered against the aforesaid accused (1) Sajal Chakraborty (40Yrs.), (2) Sudip Chakraborty (41Yrs.), (3) Prasanta Sarkar (42 Yrs.), (6) Saumik Chatterjee (40 Yrs.), (5) Anil Singh (28 Yrs.) & (6) Gajendra Trojaram Kolapur (46 Yrs.) as well as the owner of "THE HOTEL EMPEES" namely (7) Mani Pal (66 Yrs.) & his staff (8) Suhan Roy (31Yrs.) under proper sections of law and arrange to make its investigation.
