In producing herewith seven (07) arrested accused persons who disclosed their names as (i) Dipak Bhagat (21yrs) S/o- Hardu Bhagat of Kawakhali Bazar, near North Bengal Medical College, PS-Matigara, Dist-Darjeeling, (ii) Nityajit Tewari (52yrs) S/O Lt. Nepal Chandra Tewari of Gatebazar, Ward No-32, PS-NJP, Dist-Jalpaiguri, (iii) Debojyoti Dey (40yrs) S/O- Lt. Depak Kr. Dey of Shaktigarh Road no-05, Ward No-31, PS-NJP, Dist-Jalpaiguri, (iv) Dipankar Sarkar (32yrs) S/O- Lt. Manik Sarkar of Matigara toombarjote, PS-Matigara, Dist-Darjeeling, (v) Santosh Kumar (18yrs) S/O- Arun Ray of Kacchidarga, Pankaghat, Patna Bihar A/P-Sevoke Road, Tarak Nath Guest House, PS- Siliguri, Dist-Darjeeling, (vi) Rajesh Saha (27yrs) S/O- Bikash Saha of Jyotinagar Colony, Ward No-4, PS-Siliguri, Dist-Darjeeling and (vii) Basu Das (60yrs) S/O- Lt. Laxman Das of Deshbandhupara, Gopalmore, Ward No-30, PS-Siliguri, Dist-Darjeeling. I, SI Gopal Chandra Mandal of Siliguri PS/ SPC do hereby lodge complaint against the above noted arrested persons to the effect that, on 03.07.2021 at 18.25 hrs during my Mobile Van duty myself alongwith my accompanied force had been to Mahabirsthan area, Siliguri and found the above noted persons were roaming without wearing mask on their face and without any proper reasons.

On being asked, the above noted persons stated before me that, they were well aware of the pandemic situation and they supposed to remain in home and not to come out without any valid reason and without valid movement pass issued by the local Police authority or civil administration.

Hence, they violated the order of Govt. of West Bengal duly promulgated in order No. 160/C dated 22.07.2020 and order no- 647-ISS/2M-22/2020 dated 15.05.2021 and Order no- 713-ISS/2M-22/2020 dated 31.05.2021, Order no.753-ISS/2M-22/2020 dt.14.06.2021 and 753/II-ISS/2M-22/2020 dated 28.06.2021. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities.

Now, I request you for starting a case u/s- 188/269/270 IPC R/W Sec. 51(b) Disaster Management Act, 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
