In producing here with 01 (one) arrested accused person namely Ashis Oroan (M/22) s/o Lt. Manga Oroan of Uttar Palash, PO-Champasari, PS-Pradhannagar, Dist-Darjeeling along with one seized (01) Tractor bearing Reg. No. WB 73 C 8166 attached with trolley loaded with river bed materials seized under proper seizure list.

With due respect and humble submission I, PSI Chetan Dangal of Pradhannagar PS, SPC would like to lodge a written complaint against the above noted arrested accused person to the effect that on 08.07.2021, at 22:45 hrs. I along with ASI Anup Sarkar, C-830 Pradip Roy, CV 131 Ranjan Sharma CV-645 Panka Gupta in course of my spl. Mobile van duty, vide Pradhan Nagar Ps GDE No. 447 dtd. 08.07.202 received source information that one loaded vehicle was seen carrying river bed material without authorization and valid document moving towards Champasari more under PS Pradhannagar . Accordingly, I informed the matter to you and as per your kind direction I along with above noted officer and force promptly rushed to the spot (i.e Milan More Picnic Spot River Bank) and found that the above noted vehicle was being loaded with river bed materials by laborers. On seeing the police paily the laborers fled away but somehow I managed to detain the above noted tractor driver. On being asked he gave me his name and address as noted above. On demand the truck driver failed to produce any documents/papers in favor of the carried substances (river bed materials) and also failed to produce papers in support of the said vehicle. During enquiry it could be learnt that the river bed materials were loaded from Milan More Picnic Spot River Bank under Pradhan Nagar PS illegally. Thus, it is suspected that the organized racket in operation for carrying riverbed materials illegally for wrongful gain and thereby causing huge revenue loss to the Government of W.B. Hence, as such I seized the trucks loaded with river materials and arrested the driver of the vehicle noted above with proper seizure list and arrest memo respectively. The seizure and arrest was done in between 23:10 hrs to 23:25 hrs.

Under the above circumstances, I pray that a specific case may kindly be started against the arrested person namely Ashis Oroan (M/22) s/o Lt. Manga Oroan of Uttar Palash, PO-Champasari, PS-Pradhannagar, Dist-Darjeeling and arrange for its investigation.
