Sir,

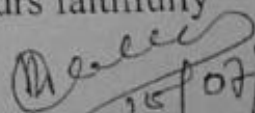
In producing herewith the one (1) Vehicle No. WB73D-7086 (Dumper) under seizure loaded with Stone Chips alongwith relevant document, I SI Mijanur Rahaman of Bagdogra P.S, SPC would like to submit that on 10.07.2021 at 06.55 hrs in returning to PS from my night mobile van duty, vide GDE No. 510 dtd 09.07.2021 and MCC. No.1112/21 dtd 09.07.2021, while myself alongwith C/269 Manik Modak and C/506 Tarapada Singha, reached at Gossainpur More found one Vehicle No. WB73D-7086 (Dumper) was coming from Matigara side along the road and on seeing our Police Van, all on a sudden, the driver of the said Vehicle stopped the Vehicle and got down from the Vehicle and fled away from the spot leaving his Vehicle and on searching the said Vehicle was found loaded with stone Chips and we searched the surroundings the area but neither the driver of the Vehicle nor anyone came forward. So, there is sufficient reason to believe that the said Vehicle loaded with stone chips was taken either by theft or any other fraudulent means and finding no other alternative, I seized the Vehicle No. WB73D-7086 loaded with Stone Chips under proper seizure list observing all formalities, the seizure process was made in between 07.15 hrs to 07.30 hrs.

Under the above circumstances, I pray to your honour that a specific case under proper section of law may kindly be registered against the driver of the Vehicle No. WB73D-7086 (Dumper) and arrange for its investigation.
