Occurre:

In producing herewith the arrested accused person namely Md Dulal 44yrs s/o Anisur Rahaman of Keshoghara PO, Raipur PS, Patharkatta Dist, Kishanganj Bihar along with the seized Vehicle No. RJ07GC-0045 twelve wheeler loaded with Stone Chips, I beg to submit that tonight on 10/11-07-2021 at 00.15 hrs in course of my night mobile van duty, vide GDE No. 570 dtd 10-07-2021, I along with force near at Gosainpur More and found the mentioned Vehicle was coming towards Bagdogra Bihar More from Matigara side along the road and intercepted the same. On searching, the said vehicle was found loaded with Stone Chips. On demand, the accused person Md Dulal, the driver of Vehicle No. RJ07GC-0045 failed to produce any valid documents or license in support of him for lifting and transportation of the same loaded articles.
