F.I.R./Complaint

Sir,

I, the undersigned, do lodge this written information as categorically stated herein below :-

1. Yesterday (dated 09.07.2021 at about 03.30 p.m. I suddenly received one information that some labourers have trespassed into my land below scheduled. Immediately I alongwith my well wisher went to my land and enquired as to why they have illegally entered into my land and on enquiry it was revealed that they are working under the instruction of Sri Basudeb Ghosh, Sri Kanu Saha and Md. Munna and others. The names and the address of Sri Basudeb Ghosh, Sri Kanu Saha and others are mentioned below. The labourers on being asked to stop their illegal work left the spot but today I have learnt that they have again illegally entered into my land and are carrying their illegal work.

2. Yesterday, later I found that the labourers have removed illegally my wooden planks, boundary wooden poles/fencing, barbed wires and steel net and other building materials and other things and they have also damaged my boundary fencing walls in / from my land at the direction of said Sri Basudeb Ghosh, Srei Kanu Saha and Md. Munna.

3. Be it noted I have already lodged complaint before your authority and other authorities .

4. Be it further noted that I have also filed a case vide Petition Case No. 82/2021 u/s 144 Cr.P.C. before the Ld. Special Executive Magistrate, Siliguri Commissionerate Office, Siliguri, Dt. Darjeeling and the Ld. Magistrate has been pleased to direct the police to maintain peace and tranquility and to keep strict vigil in the land below scheduled vide order dated 08/07/2021 with other orders..

I therefore request you to start a strong case against all those who have violated the Ld. Court's order and for committing serious offences to save life and property of innocent people and to stop their illegal motive to grab my land and oblige.
