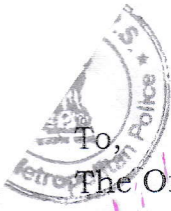




The facts of the case in brief are that today that on 11/07/21 at about 18.05 hrs in course of my mobile duty at Bihar More area then the as noted above was found were roaming at Bihar More area without any reason as well as without mask .Accordingly, I stop them and ask to reason for roaming at that area as the government announces to save people from the spread of compassion disease of COVID -19 but they could not give any satisfactory reason for their roaming at that area . Accordingly I apprehended them for disobeying Government order vide Memo no 486/CS/2021 dated 24.04.2021 and order No 647-ISS/2M-22/2020 dated 15.05.2021 as well as to avoid risks to human life and health as they violating the provisions of 188 IPC.

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law.
