Sir,

In producing herewith one accused person namely Dharendra Barman (61/M) S/O Lt. Debendra Barman of Sukantapally, PO- Pradhan Nagar, PS- Matigara, Dist.-Darjeeling under arrest along with following seized articles viz (I) 23 (Twenty Three) bottles of Rhino Gold Premium whisky each bottle containing 750 ml. and each bottle MRP Rs-250/ Total value Rs-5750/ marked as "Exhibit-A". (II) 01 (one) bottle of Rhino Gold Premium whisky taken out from Exhibit- A as sample for examination and marked as "Exhibit-A-P". I ASI Nitai Mandal presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodge the written complain against the above noted accused person that today on 10.07.2021 at 22.15 hrs. while performing special raid duty myself along with C/1035 Santosh Rabi Das, C/1008 Kanak Roy CV-155 Sukumar Das had been to Sukantapally area and found that the aforesaid person has stored huge quantity of Illicitly distilled liquor at his at his Grocery for selling. Then I cordoned the grocery shop with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he is the owner of the Grocery shop. On being search in presence of two available witnesses the above noted seized articles are found inside the shop. On being asked he failed to produce any license /papers for selling and storing of such articles. Then I seized the above mentioned articles in presence of witnesses and subsequently, arrested the above mentioned person. While on the time of cordoning off the place the persons who were having liquor at the house manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 22.45 hrs. to 23.20 hrs.

Hence I request before you that a specific case under proper section law has been initiated against the arrested Dharendra Barman (61/M) S/O Lt. Debendra Barman of Sukantapally, PO- Pradhan Nagar, PS- Matigara, Dist.-Darjeeling and arrange for its investigation.
