I am currently making a Tin Shed at my land for shop purpose for which I had kept some M.S. Angle, Patti, channel, Rod total measuring about 150 kg at my place and also there were several machines i.e. 14" Metal cutting machine of KPT company, two 4" Metal cutting machine both also of KPT company and one marble cutting machine along with all other tools such as hammer, chisel, measuring tape and wise. tools which all belonged to my workers who use to work there.

Yesterday at 10 pm I closed my godown and locked it at night when workers finished their work and I came back home. Today in the morning when I went to my place at around 9.30 am I found all the above mentioned items missing at my place and was theft by someone yesterday night most probably.

So, I therefore request you to kindly look into this matter and kindly help me to catch the thief and recover my lost things.
