In producing herewith one arrested accused person namely 1)Kartick Sah(22) s/o Chandrika Sah of Gate Bazar word no 01 Ram Thakur Mandir PS- Pradhannagar, Dist- Darjeeling seized articles viz (i) 09(Nine) Bottle Royal Choice country spirit 60 up each bottle 300ml out of which one bottle 60 UP country spirit was taken as sample for examination and marked as exhibit "A' and "A-I", (ii) 09 bottle Kingfisher Strong premium Beer each bottle containing 650 ml of which one bottle of Kingfisher Strong premium Beer was taken as sample for examination and marked as exhibit "B' and "B', iii) 09 (nine) plastic bottles of Hinmalayan Gold Country spirit 60 up each bottle 300 ml. of which one bottle was taken as sample for examination and marked as exhibit "C' and C-I as per the seizure list (which is enclosed herewith), I ASI Ratan Pradhan of Pradhannagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against one the above noted accused person to the effect that on 10.07.21 in course of spl raid duty at 18.10 hrs received a secret source information that one person illegally selling liquor inside his house cum shop situated at Gate bazaar under PS Praddhannagar Dist- Darjeeling without any valid license.

Accordingly I informed the matter to I/C Pradhannagar PS, SPC and as per kind direction myself along with, , ASI Debasish Das CV 131 Ranjan Sharma left for the spot by govt vehicle to verify the reracity of source information. On reaching there I tried to search disinterested witnesses but due to lock down no body found available there. On being identified by the source, it was found that the mentioned person was selling liquor inside his house to the customers. On seeing our team the customers and house owner tried to flee away leaving the liquors which was selling to the customers. But police team managed to apprehend the above noted person. On being asked to the apprehend person it came to learnt that the he is owner of his house cum shop. He during lock down collected the above liquor from heather and thither for the purpose of selling to the common customers in high price at that house since long for his wrongful gain without any valid paper. Accordingly, in the very presence of above noted witnesses conducted search of the said house cum shop and above noted liquors were recovered. Accordingly I scized the liquors from the house cum shop of accused person under proper seizure list duly signed by the witnesses. Seizure was made on 10.07.2021 between 20:05 hrs to 20.45 hrs. Then I, labeled the seized articles (ully signed by the witnesses as well as apprehend person. On Examination it came to earnt that the house cum shop owner involved for running this illegal business of liquor at the said house cum show under cover of darkness during lock down period without any license or permission from the appropriate authority in the close vicinity of Public Place.

Hence I request you to start a specific case under proper section of Bengal Excise Act- 1909 as mended till date against the arrested accused Kartick Sah(22) s/o Chandrika Sah of Gate Bazar word no Ram Trakur Mandir, PS- Pradhannagar, Dist- Darjeeling and kindly arrange for its investigation.
