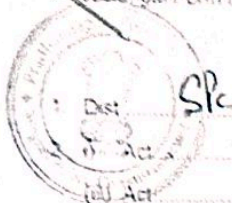

Sir,

In producing herewith the one (01) accused person Jaydeb Jha @ Jeeba (29), S/O- Lt Jay Kishore Jha of Champasari, Jyoti nagar Colony, P.S.- Pradhan nagar, Dist- Darjeeling, of in custody and the following property under seizure, along with seizure list (i) 72 (seventy two) strips of SIMPLEX C+ Capsules, containing each strips 08 capsules and marked as Exhibit-A, (Total capsules 576) ii) 01 (one) strip of SIMPLEX C+ Capsule, containing 08 capsule taken as sample from Exhibit A for examination and marked as Exhibit-A1, iii) One red colour carry bag, iv) One blue colour Bajaj Avenger Motor cycle bearing Reg. No WB74AK-4622 in which the above noted articles was kept.

I, ASI Ratan Pradhan of Pradhannagar P.S., SPC do hereby lodged this complaint to the effect that on 11.07.2021 at 16.10 hrs I received secret source information that one person standing with a blue colour motor cycle at beside Samar nagar main road, Champasari carrying huge quantity of illegal contraband drugs for selling the same at Champasari area. I accordingly shared the information with you and according as per your kind direction at 16.20 hrs myself along with ASI Debasis Das, ASI Ashit Singha, CV 131 Ranjan Sharma, CV 128 Ajay Kr Sahani, CV 992 Jagadish Biswas took departure for Samar nagar main road, vide PDN P.S. GDE NO 641, Dated 11.07.2021,. We reached at the spot at 16.35 hrs and then I tried to call independent witnesses to present in the operation, but due to lockdown issues none could been founde. Accordingly after being confirmed by source I apprehended the accused person carrying a red colour carry bag. After disclosing out our identity they disclosed his identity as Jaydeb Jha @ Jeeba. According I search the apprehended person. On search the red colour carry bag from the possession of the apprehended accused persons I recovered 72 (seventy tow) strips of SIMPLEX C+ Capsules, containing each strips 08 capsules and One blue colour Bajaj Avenger Motor cycle bearing Reg. No WB74AK-4622. On demand the apprehended person failed to produce any document in respect of the recovered contraband drugs or in respect of the motor cycle. Accordingly I seized the above noted articles, under proper seizure list. The seizure has made between 17.15 hrs to 18.55 hrs. Accordingly at 19.05 hrs I arrested the accused person namely Jaydeb Jha @ Jeeba (29), S/O- Lt Jay Kishore Jha of Champasari, Jyoti nagar Colony, P.S.- Pradhan nagar, Dist- Darjeeling, issuing proper memo of arrest. At 19.35 hrs myself along with force with arrested accused person and seized articles brought to Pradhan nagar Police station.

Hence it is prayed that a specific case may kindly be started against the accused person namely Jaydeb Jha @ Jeeba (29), S/O- Lt Jay Kishore Jha of Champasari, Jyoti nagar Colony, P.S.- Pradhan nagar, Dist- Darjeeling, as per law.
