Sub: Information related to deceiving fraudulently and dishonestly inducing for extortion of money from the account of Indian Institute of Legal Studies, Dagapur, Siliguri by unknown miscreants.

I Sanjay Bhattacharjee, Registrar of Indian Institute of Legal Studies, Dagapur, Siliguri, would appraise you with an incident occurred on 09.07.2021 relating to transfer of money to a specific Bank Account of Union Bank of India, Kalimpong by deceiving fraudulently and dishonestly inducing the President of the Governing Body, Indian Institute of Legal Studies, Dagapur, Siliguri.

That the Honorable President of the Governing Body of Indian Institute of Legal Studies, Shri Joyjit Choudhary received a phone call in his mobile from an unknown number, being 9933765422, on 08.07.2021 wherein the unknown person introduced himself as the Personal Assistant of Shri Bimal Gurung, Prominent leader of the Gorkha Janamukti Morcha, a political party in the Hill of Darjeeling and Kalimpong and requested to have a conversation with Shri Bimal Gurung urgently.

Acting upon the conversation over telephone on 08.7.2021, with the person representing himself as Shri Bimal Gurung, our Honorable President of the Governing Body felt that it's highly called for to extend the cooperation for the people of Hill areas as our Institute actively undertakes various charitable activities at the behest of our Institute on all possible occasions. Accordingly, being felt the necessity of the charitable activities, and as per direction of our Honorable President, on 09.07.2021 our Institute transferred a sum of Rs.One Lake to a Bank Account bearing no. 393602010019399 that was provided by the said person over the telephone and in fact maintained by one Tara Pariyer at UNION BANK OF INDIA, KALIMPONG Branch. The amount of Rs. One Lakh has been transferred from our college bank account, maintained at HDFC BANK, SHIVMANDIR BRANCH through electronic transfer.

Later on, the said person again called our Honorable President and asked for more contribution an additionally demanded Rs Two Lakh on 10.07.2021 over the phone and the same created an iota of doubt about the identity of person and the manner in which he was demanding. Immediately, after verification through reliable sources, it is found that said unknown persons had completely cheated our College/Institution and have induced us by deception and with dishonest intention to extract money from the gethisthane and to cheat the Contd.P/3 Institute.
