With due respect, in producing herewith (1) one 01 (one) Truck bearing Registration No. WB 76 A 5946 loaded with Sand as per seizure list.

I, ASI Ramesh Bhitrikothey presently posted at Bhaktinagar P.S., SPC do hereby submit the written complaint to the effect that on 09.07.2021 myself along with force C/707 S. Ghosh and C/1011 R. S. Sonar had been performing K-38 III Van Duty vide GDE No. 509 Dated 09.07.2021 MCC No. 2619/2021 Dated 09.07.20121. In course of performing mobile van duty, received an information from secret source that 01 (one) vehicle bearing No. WB 76 A 5946 loaded with illegal sand had been coming from Matigara side towards Check Post along NH 31 C. I shared the information with I.C. PS and as per his direction, I along with force rushed to Biswanath More and started checking vehicles. At around 23.15 hrs, I along with force could see one Truck approaching towards Biswanath More. When I along with force gave signal using torch light to stop, the driver immediately stopped the vehicle and jumped out of the said Truck and fled away. On physical verification of it could be found that the truck was loaded with sand. On search inside vehicle no documents of sand could be found.

Under the above noted circumstances, it is evident that the driver / owner along with others received dishonestly procured the sand through illegal mining from river bed of Unknown River and transported the same for fraudulent disposal for their wrongful gain. Accordingly, I seized the above noted truck with loaded sand under proper seizure in presence of witnesses U/S 102 CrPC.

I, therefore, pray before you that a specific case may kindly be started against the driver / owner of the above noted truck and others and arrange for its investigation.
