Accordingly, I arrested them u/s 41 CR:P.C in c/w tre apove case. Hence, I request you for starting a specific case u/s 188/269 IPC R/W Sec 51 (b) Disaster Management Act, 2005 against the above noted arrested persons and arranged to proper investigation of the case.
