Sir,

In producing herewith one accused person namely Bijay Mandal (26), S/O- Hari Mandal of Shantinagar Bou Bazar PS Bhaktinagar Dist Jalpaiguri and the following articles under seizure:

(1) 20 (Twenty) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total- 12 Liter & Amount Rs 2000/-)

I SI Partha Sarathi Das O/C Ashighar OP lodged a written complaint against the accused person namely Bijay Mandal (26), S/O- Hari Mandal of Shantinagar Bou Bazar PS Bhaktinagar Dist Jalpaiguri to the effect that, on 10.07.2021 evening as per order of I/C Bhaktinagar PS 1 along with ASI Ujjal Mnadal C/ 877 Munna Ahamed, and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashighar OP as per order vide Ashighar OP GDE no. 289 Dt 10.07.2021 in course of which I received information from my source that one Bijay Mandal stored a huge numbers of bottles liquor inside his house at Shantinagar Bou Bazar and used to sell to the local youth in higher rates. I immediately informed I/C Bhaktinagar PS and as per his kind direction wasting no time I along with my accompanied party left for Shantinagar Bou Bazar area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan Nager w/no 36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Shantinagar Bou Bazar area as indicated by my source I held raid at the house Bijay Mandal at shantinagar Bou Bazar. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 20.15 hrs and 20.30 hrs on 10.07.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Bijay Mandal (26), S/O- Hari Mandal of Shantinagar Bou Bazar PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
