In producing herewith the following accused namely (1) Sandip Sarkar (25) S/O Late Naresh Sarkar C/O Sujala Sarkar Papiapara Near Krishna Youbok Sangha Club P.S Bhaktinagar Dist. Jalpaiguri (2) Subho Das (21) S/O Bhobesh Das of Purba Chayanpara PS Bhaktinagar Dist. Jalpaiguri (3) Ajit Sahani (22) S/O Late Ram Das Sahani of Natun Bazar Dakshin Palas PS Pradhan Nagar Dist Darjeeling (4) Bikram Das (25) S/O Charan Das of Purba Chayan para Near Rajen Panchyat's house PS Bhaktinagar dist. Jalpaiguri and (5) Subrata Bhowmik (19) S/O Ratan Bhowmik of Kankata More PS Bhaktinagar Dist Jalpaiguri, in custody along with the following seized articles:-

- i. One (1) knife made of iron measuring approx 11 inches length including fiber handle was recovered from the possession of accused Sandip Sarkar (25) S/O Late Naresh Sarkar C/O Sujala Sarkar Papiapara Near Krishna Youbok Sangha Club P.S Bhaktinagar Dist. Jalpaiguri -
- ii. One (1) iron sword measuring about its 2 feet 9 inches including iron blade and handle was recovered from the possession of accused Subho Das (21) S/O Bhobesh Das of Purba Chayanpara PS Bhaktinagar Dist. Jalpaiguri.
- iii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Ajit Sahani (22) S/O Late Ram Das Sahani of Natun Bazar Dakshin Palas PS Pradhan Nagar Dist Darjeeling
- iv. One(1) iron rod measuring about 3 feet in length was recovered from the possession of accused Bikram Das (25) S/O Charan Das of Purba Chayan para Near Rajen Panchyat's house PS Bhaktinagar dist. Jalpaiguri

i. S.I Pradip Kr Singha of Ashighar OP P.S Bhaktinager would like to lodge this written complaint against the above noted accused persons and also 09/10 other unidentified persons to the effect that today i.e. on 10.07.2021 at about 21.05 hours received a secret source information that a group of 14-15 persons have assembled at Fakdaibari Necha busty Near Shahu river under Bhaktinager P.S, Dist-Jalpaiguri with deadly weapons with a view to commit some heinous crime. Accordingly without wasting any time I informed the matter to I.C, Bhaktinager P.S and diarised the whole fact in Ashighar OP GDE No. 292 dated 10.07.2021, Then at 21.10 hrs, as per instruction of O.C Ashighar OP I along with ASI Ujjal Mandal, ASI Sumit Baran Nath C/1181 Bhabesh Ch Roy, CV/1016 Amrit Roy all of Ashighar OP left for spot to verify the veracity of the information and to work upon it, noted in Ashighar OP GDE NO. 293 dt- 10.07.2021. We reached near the spot as directed by the source at about 21.35 hours and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. On way we meet two respectable persons of the locality namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghogomali PS Bhaktinager dist. Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjana Nagar w/no. 36 PS Bhaktinagar Dist. Jalpaiguri and to whom we disclosed our motto and identity and asked them to accompany us if any search and seizure is necessary for the purpose and they agreed. We reached at the Fakdaibari Necha busty Near Shahu river at about 21.50 hrs and found a group of 14-15 persons sitting at the Fakdaibari Necha busty Near Shahu river. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing away. Anyhow, after a hot chase we could able to apprehend the 05 above referred accused persons. After apprehension the 05 persons disclosed their identity as noted above and also stated that there were 09/10 other persons with them and they were planning to commit a

dacoity on the house of a businessman at Kankata More area. Thereafter all the apprehended persons were searched in presence of the witnesses and the following articles were seized as follows:-

- v. One (1) knife made of iron measuring approx 11 inches length including fiber handle was recovered from the possession of accused Sandip Sarkar (25) S/O Late Naresh Sarkar C/O Sujala Sarkar Papiapara Near Krishna Youbok Sangha Club P.S Bhaktinagar Dist. Jalpaiguri
- vi. One (1) iron sword measuring about its 2 feet 9 inches including iron blade and handle was recovered from the possession of accused Subho Das (21) S/O Bhubesh Das of Purba Chayanpara PS Bhaktinagar Dist. Jalpaiguri.
- vii. One (1) house breaking implement made of iron with pointed end measuring about 21" in length was recovered from the possession of accused Ajit Sahani (22) S/O Late Ram Das Sahani of Natun Bazar Dakshin Palas PS Pradhan Nagar Dist Darjeeling
- viii. One (1) iron rod measuring about 3 feet in length was recovered from the possession of accused Bikram Das (25) S/O Charan Das of Purba Chayan para Near Rajen Panchyat's house PS Bhaktinagar dist. Jalpaiguri

Thereafter all the articles were seized in-between 22.05 hrs to 22.25 hrs. Issuing a proper seizure list duly signed by the witnesses and the accused persons. Thereafter all the persons were arrested after observing all formalities of arrest them as they are assembled for committing heinous crime.

On the above circumstances, I pray before you that a specific case may kindly be started against the 05 arrested accused persons namely (1) Sandip Sarkar (25) S/O Late Naresh Sarkar C/O Sujala Sarkar Papiapara Near Krishna Youbok Sangha Club P.S Bhaktinagar Dist. Jalpaiguri (2) Subho Das (21) S/O Bhubesh Das of Purba Chayanpara PS Bhaktinagar Dist. Jalpaiguri (3) Ajit Sahani (22) S/O Late Ram Das Sahani of Natun Bazar Dakshin Palas PS Pradhan Nagar Dist Darjeeling (4) Bikram Das (25) S/O Charan Das of Purba Chayan para Near Rajen Panchyat's house PS Bhaktinagar dist. Jalpaiguri and (5) Subrata Bhowmik (19) S/O Ratan Bhowmik of Kankata More PS Bhaktinagar Dist. Jalpaiguri and 09/10 others unidentified persons for such assemble with deadly weapons and arrange for its investigation.
