I Smt. Moitryee Chatterjee, W/o Sri Subrata Chatterjee, resident of Dabgram, Under SMC ward No. 23, Rabindra Sarani, P.S. Siliguri, Dist: Darjeeling do hereby lodge this complaint on the following effects with the request for taking immediate action

1) That after completion of my education I was married to Sri Subrata Chatterjee, S/o Prasant Chatterjee on 03.12.1998 socially in siliguri according to Hindu Rites & Customs. I state that at the time of marriage as per demand of my in-laws and husband, my own father has given the gold ornaments, utensils, furnitures, etc and also cash money of Rs.2,00,000.00 (Rupees Two lakhs only) and after marriage I was taken to my matrimonial house at Tekia Para, Railway Quarter, Siliguri wherein I started to lead my conjugal life with my husband & in-laws and moreover during conjugal life I became pregnant but unfortunately during pregnancy I was subjected to mental torture by my husband and later on, on 06.12.2002. I have given birth of a female child namely Miss Anwesha Chatterjee. I also state that within few months of marriage I have realized that my husband is a notorious type of man and during night time all most in every day he came and still comes in a drunken condition and without any reasons started to assault me but despite the said mental and physical torture initially I could not disclose the same to my own old parents apprehending that they may be in mental distress if

they hear such type of my mental & physical torture but unfortunately day by day the said mental and physical torture has been increased and subsequently as per demand of my husband my parents started to pay further cash money sometimes Rs. 40,000.00 (Rupees Forty thousand only), sometimes Rs. 50,000.00 (Rupees Fifty thousand only) and in this way my parents has further paid of Rs. 10,00,000.00 (Rupees Ten lakhs only) in cash to my husband for starting business which is very much painful for me but unfortunately even after payment of money, my husband did not stop mental and physical torture upon me. He even put me in trouble many a times by taking money from random money lenders for his own purpose.

- l state that that my husband earns handsome amount monthly by way of different kinds of business but even after earning the said handsome amount, my husband since marriage did not incur the required expenses not only towards me but also towards my child for our livelihood and for that reasons, every occasion my father started to provide financial help to me for myself and for my child's livelihood and thus being a father, my husband did not discharge his duty towards me & towards my child and moreover maximum amount of his earnings he misused and still is misusing for his alcoholic purpose and for extra marital affairs with different ladies and as a result since my marriage I am subjecting to mental and physical torture by my husband in my daily life which is very much shocking to my child.
- 3) I state that in the year 2008 a residential flat has been purchased vide registered sale deed No. 727 dated 23.04.2008 in the name of my husband with the financial help from bank as well as after availing financial help in cash from my own parents. I state further that I asked my husband to purchase the flat jointly in my name as well as in the name of my husband but my husband taken the plea that as I am having no income tax file, the flat can be purchased in his name only and accordingly the said flat has been registered in the name of my husband at

Dabgram, Siliguri situated in the first floor of the building wherein still I and my daughter are residing with my husband and are passing our painful life.

4) That for the last few months my husband save and except the mental and physical torture, started to create situation so as to drive me out from my matrimonial house on the plea that the concerned flat is in his name i.e. in the name of my husband but now a days it has reached to such an extent that in any moment my husband may sale out the said flat as every day my husband is threatening me that he will sale out his said flat & will maintain live in relationship with another lady and thus if the said flat is sold out by my husband, then I and my daughter will be on road and will be suffering from irreparable loss and as such finding no option I am lodging this complaint before you with the request to take appropriate step immediately against my husband so that I and my daughter will not be ousted from my husband's house forcefully by any means and we will not be subjected to further mental and physical torture.
