With due respect and humble submission that I ASI Sanjay Hasda of Khalpara TOP-II under Siliguri PS(SPC), beg to inform you that on Dated 09.07.2021 at about 02:45hrs. while I was performing M.C Night duty within Khalpara TOP area along with C-1072 Anand Thakuri (Ref:-Khalpara TOP GDE No-317/21, Dated-09.07.2021 vide M.C.C N O-1032/21) and when we reached at Siliguri Bazar Road behind Former Urbashi Cinema Hall, W/NO-08, PS Siliguri, Dist-Darjeeling at that time the following persons namely (1) Gourav Agarwal(25)yrs.S/O Bikram Agarwal (2) Yashik Agarwal (21)yrs.S/O Bikram Agarwal (3) Ankur Agarwal (24)yrs.S/O Ashok Agarwal (4) Ashok Agarwal S/O Mahabir Prasad Agarwal(5) Smt.Rani Devi Agarwal(51)yrs.W/O Bikram Agarwal all are residence of Siliguri Bazar Road behind Former Urbashi Cinema Hall, W/NO-08, PS Siliguri, Dist-Darjeeling along with others unknown persons out them Gourav Agarwal and Yashik Agarwal along with their male family members and associate noted above were drinking alcohol out site their house at Siliguri Bazar Road and when we told them to go in side their house they suddenly snatched our LATHI and attacked on us therefore me and C-1072 Anand Thakuri received severe injury on our persons then I call the RT Van on duty and when the RT Van reached on the spot and tried to arrest the above noted persons, most of the people noted above managed to escaped from there and the following persons namely (1) Gourav Agarwal(25)yrs. (2) Yashik Agarwal (21)yrs noted above were arrested by RT Van officers and rescued us from their and the both arrested accused persons noted above along with us we are shifted to Siliguri District Hospital and the both arrested accused persons and me & C/1072 Anand Thakuri we are treated at Siliguri District Hospital.

So, Therefore please take necessary action against the above noted accused person for obstructing and assaulting graciously the public servants while performing their duties.
