Respected Sir,

With due respect I Sri Ajit Kumar Roy, Son of Sri Narayan Chandra Roy, resident of South Deshbandhu Para, P.O. Siliguri Town, P.S. Siliguri, Dist. Darjeeling, do hereby lodge this FIR to the effect stating that on 26.06.2021 at about 1:15 P.M. when I was coming by my motor cycle from my home to Siliguri Court, on the way when I reached in front of Subrata Sishu Uddyan, near open kitchen restaurant, Deshbandhu Para, Ward No. 30 of S.M.C., P.S. Siliguri, Dist. Darjeeling at that time one Maruti Alto Car (Red colour) bearing registration number WB74 BC1968 rashly and negligently hit me from my left side as a result I fell down on the road with my motor cycle and due to such act of rash and negligent driving I sustained injury and fracture on my left hand below elbow and also injury to my collar bone and joint on the left shoulder as well as bruise on right hand.

Soon after the accident when the local people started coming to help me at that time the driver of the offending vehicle number WB74 BC1968 fled away with the vehicle.

After that I got treated myself for injury by doing x-ray and I am still undergoing treatment as such there is delay in lodging this FIR and the delay may kindly be condoned from your side for justice.

Hence I request you to kindly register this complain as FIR and take legal action against the driver of the offending vehicle.
