Sir,

In producing herewith 05 (Five) arrested accused persons who disclosed their identity as (i) Bipul Mahato (32) S/O Sri Biswanath Mahato of Chakda Pat PS- Hilli Dist-Dakshin Dinajpur. (ii) Puja Roy (62) S/O sri Basudeb Roy of Ketaulia PS- Banraj Dist-Muzaffarpur (Bihar). (iii) Sanjay Roy (38) S/O Bodhar Roy of Ketaulia PS- Banraj Dist-Muzaffarpur (Bihar). (iv) Md. Basim (35), S/O Md. Salim of Vivekananda Nagar Coal Depo Ward No-07 PS- Siliguri Dist- Darjeeling. (V) Ujjal Barman (21) S/O sri Naresh Barman of Sanyasi Dham PS- Mathabhanga Dist- Coochbihar.

I, SI. Md. Shajahan Ali of Khalpara TOP under Siliguri PS, SPC do hereby lodge complaint against the above noted arrested persons, to the effect that while on 09.07.21 at 12.05 hrs performing Special mobile van duty myself along with force C/110 Kamal Ch. Roy C/1187 Ganesh Sarkar had been to Jhankar more, Khalpara, Siliguri vide Khalpara TOP GDE No-309 dated 09.07.2021 and others and found that the above noted persons and others made unnecessary gathering at the public places without wearing mask. On being asked the above noted persons stated that they were well aware of the COVID-19 pandemic situation and disobeyed the Govt guidelines without any valid reason.

Hence all of them violated the order of Govt. of West Bengal duly promulgated and circulated by Civil and Police authorities in order no -486-CS/2021 dated 24.04.21 arising out of order No- 79-CS/2020 dated 12.04.2020, wearing of facial mask has been made mandatory in public places in the current pandemic disaster situation and to prevent spread of COVID-19.. The above noted persons have intentionally refused to comply with the order of Govt. of West Bengal duly promulgated in view to stop the break- out of Pandemic COVID- 19 throughout the Country. Accordingly I arrested them after issuing proper arrest memo and maintaining health protocols ensure their safety and security.

So, I therefore request you for starting a specific case under proper section of law against the above noted arrested accused persons and arranged proper investigation of the case.
