Respected Sir,

I, Smt Priya Mallick, W/o Lalit Mallick, resident of surya nagar, gate no. 01, Shivmandir, P.S. Matigara, District — Darjeeling, do hereby lodge this complaint against my husband Lalit Mallick, Brother-in-Law Rupesh Mallick, son of Ganesh Mallick and my father-in-Law Ganesh Mallick to the effect that I was married to Lalit Mallick, son of Ganesh Mallick on 10.12.2017 who is a contractual worker as a house keeping on the daily basis. Since the inception of marriage I have been victimize of mental and physical cruelty by my husband Sri Lalit Mallick and my brother-in-law Sri Rupesh Mallick, son of Ganesh Mallick and my father- in-Law Ganesh Mallick. The aforesaid three persons over the years have physically assaulted me on many occasions but I kept mum for the sake of welfare of my elder son aged about two and half years and small son aged about only 13 days. And they physically assult me after 13 days of delivery of my small son and my stich did not cut till now by forcibly of my husband.

Today at evening time about 8:00 p.m. when I along with my minor sons and my elder minor son was demanding for some food and he came to me and I was with my small son, the said LALIT MALLICK forcefully pulled me and two sons from my custody and abused me in a filthy language and pulling my hair the said three persons which I mentioned above their names and they are LALIT MALLICK, RUPESH MALLICK, GANESH MALLICK started assaulting me with fists and blows in my body parts and threatened me to leave their house or else they will forcefully throw me out of their house and that they will even kill me if required. Thereafter the said LALIT MALLICK, RUPESH MALLICK and GANESH MALLICK physically assaulted me in an outrageous manner and touched my private parts and turn by turn they kicked me in my womb and also hitted me by belt. Then the said three persons tied my leg and hit me with kick, in my legs, back, hand, head and other body parts and attempted to kill me to which I became unconscious and I was taken to Bagdogra Hospital by my parents family. I have sustained serious injuries due to their assault and my whole body is in swollen condition and the doctor prescribed me for X-RAY of my back and city scan of my brain & I am not able to walk of my own.

I request to kindly initiate necessary legal actions against the said persons for the ends of justice.
