Sir,

In producing herewith arrested accused person namely Mahindar Mahaseth @ Doctor (56) S/O Late Boakai Mahaseth of Tikiapara, Matangini-II, Ward No. 28, PS-Siliguri, Dist- Darjeeling along with seized articles vize- i) 07 sealed bottles of 07 years Blended Old Monk XXX Rum containing 180 ml each amounting of Rs @ Rs 153/- each (Amounting of 07 x Rs 153/- =RS.1071/-) , ii) 05 ( Five ) sealed bottles of Officer's Choice Deluxe Whiskey containing 180 ml each (Amounting of 05 x Rs 140/- =RS.700/-) , iii) 07 (Seven) sealed bottles of Imperial Blue Classic Grain Whiskey containing 180 each (Amounting of 07 x Rs 174/- =RS.1218/-), iv) 05 Sealed Bottles of Sterling Reserve Classique Blended (B-7) Whiskey containing 180 ml each amounting of Rs. 204/- each (Rs. 204/- x 05 = Rs. 1020/-, and v) 04 sealed bottles of Royal Challenge Premium Gold Whiskey containing 180 ml each amounting of Rs. 241/- each ( Rs. 241/- x 04 = Rs. 964/- ) ( Total amount of Rs. 4973/- ) as per seizure list.

I, ASI Siben Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Mahindar Mahaseth @ Doctor (56) S/O Late Boakai Mahaseth of Tikiapara, Matangini-II, Ward No. 28, PS-Siliguri, Dist- Darjeeling to the effect that on 10.07.21 at 14.25 hrs I received a source information that the above noted person was busy to sale Id liquor illegally at his house situated at Tikiapara, Matangini-II, Ward No.28, under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no. 672 dated 10.07.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with CV/622 Ramanath Barman and CV/283 Prosenjit Dey left Tikiapara, Matangini-II, Ward No.28, under Siliguri PS GDE NO: 673 dated 10.07.21 to verify the veracity of the information. On reaching at 14.55 hrs there and as identified by source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person

tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, the above noted person disclosed his identity as noted above. On searching - - i) 07 sealed bottles of 07 years Blended Old Monk XXX Rum containing 180 ml each amounting of Rs @ Rs 153/- each (Amounting of 07 x Rs 153/- = RS.1071/-), ii) 05 ( Five ) sealed bottles of Officer's Choice Deluxe Whiskey containing 180 ml each (Amounting of 05 x Rs 140/- = RS.700/-), iii) 07 (Seven) sealed bottles of Imperial Blue Classic Grain Whiskey containing 180 each (Amounting of 07 x Rs 174/- = RS.1218/-), iii) 05 Sealed Bottles of Sterling Reserve Classique Blended (B-7) Whiskey containing 180 ml each amounting of Rs. 204/- each (Rs. 204/- x 05 = Rs. 1020/-, and iv) 04 sealed bottles of Royal Challenge Premium Gold Whiskey containing 180 ml each amounting of Rs. 241/- each ( Rs. 241/- x 04 = Rs. 964/- ) ( Total amount of Rs. 4973/- ) which was kept concealed in his house. On being interrogation he could not produce any valid documents in respect of the said liquor. He also stated that he is doing this liquor business since last ten (10) months approx for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.15 hrs to 16.00 hrs. On being asked he stated that he used to sale the same to locality without any valid documents as he has violated the norms of Bengal Excise Act as such I arrested her U/S-41 Cr.P.C after observing all sorts of rules for selling the said seized articles without any valid license.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person Mahindar Mahaseth @ Doctor (56) S/O Late Boakai Mahaseth of Tikiapara, Matangini-II, Ward No. 28, PS-Siliguri, Dist- Darjeeling under proper section of law and arrange for its investigate.
