C as there was no scope to give notice under 41 (A) Cr. P. GDE NO. 76L C. On being asked the above noted persons stated that they were well aware of the Pandemic disaster situation and they were moving here and there without facial mask & valid reason. They Started St negligently and malignantly move to spread infection of any decease dangerous to life during

Hence, they violated the order of Govt of West Bengal duly promulgated in order No. 753/II-ISS/2M-22/2020 dated 28/06/2021 and No.647-ISS/2M-22/2020 dated 15/05/2021 read PS Care No. with No 707-ISS/2M-22/2020 dated 29/05/2021 and No. 753-ISS/2M-22/2020 dated 138 138 14/06/2021 The above noted persons have intentionally refused to comply with the order of Govt. 230 39c 774 of West Bengal duly promulgated in view of break-out of pandemic COVID-19 throughout the Sec 51(b) of country. Accounding, I seized the above noted vehicles and arrested them u/s- 41 Cr.P.C in c/w the case after observing all rules and formalities. Now, I request you for starting a case u/s-188/269/270 IPC R/W Sec. 51(b) Disaster Management Act. 2005 against the above noted arrested accused persons and arranged proper investigation of the case.
