

Sir,

I, ASI Jakirul Islam of Bagdogra P.S. Siliguri Police Commissionerate, do hereby lodge this written complaint against the following arrested persons namely i) Dewraj Shaw 19yrs s/o Late Dasrath Shaw of Promodnagar PS, Bagdogra, Dist, Darjeeling ii) Firoj Hussain 27yrs s/o Late Selim Hussain of Bhujapani Kolkata Road PS, Bagdogra, Dist, Darjeeling iii) Dilip Biswakarma 34yrs s/o Sankar Biswakarma of Jyotinagar PS, Bagdogra, Dist, Darjeeling under arrest along with following articles; (i) One (01) Iron Kattan (Sharp cutting weapons) and one torch light recovered from the possession of Dewraj Shaw which was on his right hand (ii) One iron rod approx 3 fit (seems to be implement of house lock breaking) recovered from the possession of Firoj Hussain and (iii) One iron chaku (Knife Sharp Cutting weapon) recovered from the possession of Dilip Biswakarma which he was holding on his hand. Also recovered two nylon rope and one big size gunny bag two sealed Kingfisher strong premium beer and three empty Himalayan Gold 60 UP country made spirit bottle from the spot.

In this regard, I beg to report that on 16.07.2021 at 22.15 hrs received secret reliable source information that about 6/7 anti socials armed with deadly weapons assembled near Singhjhora More area making preparation to commit Dacoity at Bagdogra area. I shared the information to OC Bagdogra PS in hand and finalized the fact vide Bagdogra PS GDE No. 922 Dated 16.07.21. As per the direction of OC Bagdogra PS, at 22.20 hrs, I along with ASI Dharendra Nath Mandal, C/410 Mantosh Singh, VP/U2 Dipak Roy CV/ Pradip Roy, VP/Ansalam Kujur left for working out the information vide Bagdogra PS GDE No. 923 Dtd. 16.07.21 after briefing officer and force properly and also along with required papers / articles. At around 23.05 hrs we reached near Singhjhora more area and kept our vehicle in a considerable distance. Then, I along with Officers and force headed towards Singhjhora more area looking for witnesses, if any on the way and found two persons seen at that time on that area namely i) Anuj Oraon 25yrs s/o Late Laxman Oraon ii) Manish Tirkey 23yrs s/o Foolzen Tirkey both r/o Singhjhora PS, Bagdogra Dist, Darjeeling. By the time we reached Singhjhora more area as informed by secret source, in faint light of street lights on the south side corner, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted three persons could be apprehended and detained. Then, after disclosing our identity, I

asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address as noted above and admitted that they along with one Kabir Sk and 2/3 others assembled at the spot making preparation to commit Dacoity tonight at Panighata More one house name did not disclosed under Bagdogra PS, area. I accordingly searched them and found (i) One (01) Iron Kattari (Sharp cutting weapons) and one torch light recovered from the possession of Dewraj Shaw which was kept on his both hand (ii) One iron rod approx 3 fit recovered from the possession of Firoj Hussain (seems to be implement of house lock breaking) (iii) One iron chaku (Knife Sharp Cutting weapon) recovered from the possession of Dilip Biswakarma which he was holding on his hand and further search on the spot one rope (nylon), one gunny bag (big size) from the spot. On interrogation they admitted that they all assembled there at the behest of one house name not known were making preparation for committing Dacoity tonight in Panighata More area but one Kabir Sk and 2/3 others managed to escape from the spot. Accordingly, I seized above noted articles in presence of two independent witnesses under proper seizure list duly signed by them and arrested them informing them their ground of arrest preparing memo of arrest. The seizure was made in between 22.35 Hrs to 23.20 Hrs of dated 16.07.21.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity at nearby Panighata more area. Further, it is to mention here that the arrested accused persons are well known anti socials and have been indulged in many criminal cases.

Therefore, I pray before you to start a specific case against them and 5/6 others who fled away under proper section of law and to cause its investigation.
