I, ASI. Subhendu Das of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Uday Roy(39/M) S/O Bijoy Roy of Patharghata, Palashgurijote, PO-New Rangia, PS- Matigara, Dist- Darjeeling under arrest along with following seized articles viz ; (I) 12 (Twelve) bottles of Himalayan Gold Country Spirit each bottle containing 300 ml.(total 300 ml X 12= 3.6 Ltrs.) and marked as "Exhibit-"A" (II) 01(one) bottle of Himalayan Gold Country Spirit containing 300 ml. taken out as sample from "Exhibit-"A" for examination and marked as "Exhibit-A-1" (III) 08 (eight) bottles of Kingfisher Strong Premium Beer each bottle containing 650 ml.(total 650 ml X 05 =5.2 Ltrs.) and marked as "Exhibit-"B" (IV) 01(one) bottle of Kingfisher Strong Premium Beer containing 650 ml. taken out as sample from "Exhibit-"B" for examination and marked as "Exhibit-"B-1" (Grand total 3.6+5.2=8.8 Ltrs.) under seizure list (which is enclosed herewith) to the effect that on 16.07.2021 at 20.25 hrs received a secret source information that one person namely Uday Roy(39/M) S/O Bijoy Roy of Patharghata, Palashgurijote, PO-New Rangia, PS- Matigara, Dist- Darjeeling has stored huge quantity of Illicitly distilled liquor and country spirit at his house without any valid license. Diarized the matter vide Matigara PS GDE No.911 Dt.- 16.07.2021 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with ASI Nitai Ch. Mondal, Const- 1035 Santosh Rabi das, Const- 1008 Kanak Roy, CV- 155 Sukumar Das left for Patharghata, Palashgurijote to verify the veracity of the source information. On reaching at the spot at 08:45 hrs it was found that huge quantity of Illicitly distilled liquor and Country Spirit stored in the house of Uday Roy who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the house. But we apprehend the above noted person namely Uday Roy. There after I called two independent witnesses of that locality namely i) Sanjoy Singha (29/M), S/O-Ramesh Singha of Patharghata, Palashgurijote, PO-New Rangia, PS- Matigara, Dist- Darjeeling and ii) Babai Roy (25/M), S/O Bholanath Roy of Patharghata, Palashgurijote, PO-New Rangia, PS- Matigara, Dist- Darjeeling and in the very presence of those witnesses I search the house and seized the above noted Illicitly distilled liquors and country spirit after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Uday Roy(39/M) S/O Bijoy Roy. On being asked the said person failed to produce any document for selling and storing liquor at the house. It's a violation under Bengal Excise Act. This seizure was made on 16.07.21 in between 20:50 hrs to 21:40 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Uday Roy (39/M) S/O Bijoy Roy of Patharghata, Palashgurijote, PO-New Rangia, PS- Matigara, Dist- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of liquor at the said house and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Uday Roy(39/M) S/O Bijoy Roy of Patharghata, Palashgurijote, PO-New Rangia, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
