In producing herewith one accused person namely Biswanath Barman (28) @ Chunai S/o Lt. Uday Barman of Ambikanagar, PS- NJP. Dist.- Jalpaiguri along with the following seized articles under seizure as per seizure list:

1. Total 04 (Four) packets wrapped with Brown colour plastic Cello Tape containing 28 kgs (Twenty Eight) Kg said to be Ganja Marked as follows

I, SI Kamal Chandra Saha of Ambari O.P. under New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted accused person to the effect that on today i.e. 14.07.2021, at about 08.05 hrs received a specific source information that one person would be coming from Jalpaiguri side and proceeding towards Siliguri with a suspected consignment of Ganja Accordingly I informed the matter to SI Sajal Roy, O/C Ambari OP, SPC and requested him to strengthen by more police personnel at Nawapara More. Hence, I, diarized the fact in GDE vide Ambari OP GDE No. 416 and at 08.15 hrs, I, along with C/256 Bibhuti Mahato, C/824 Satyaban Das, NVF/108 Swadesh Roy of Ambari OP under NJP PS left OP for Nawapara More, vide Ambari OP M.C.C. No. 1817/21 Date: 14/07/2021 to verify the veracity of the information vide GDE No 447 dated 14.07.2021 by Govt. Vehicle taking necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. At about 08.30 hrs we reached at near Nawapara More and parked the vehicle at considerable distance and proceeded towards Jalpaiguri Side. Meanwhile, I called two disinterested witnesses namely 1) Subash Sarkar S/o Lt. Narayan Sarkar of 09 No. Colony, PO- Kamarvita, PS- NJP, Dist.- Jalpaiguri.2) Biswajit Chanda @ Suku Chanda S/o Lt. Purna Chanda of 09 No. Colony, PO-Kamarvita, PS- NJP, Dist.- Jalpaiguri, I disclosed our identity and informed them about the information in hand and requested him to accompany us in the whole process of search and seizure, if any. Meanwhile, our Police party started looking for accused person and finally saw one person with two Nylon bag in his hand coming from Jalpaiguri side and proceeds towards Siliguri side. We stopped him, and disclosed our identity to him. On being asked he disclosed his name and address as noted above. I told him about the information in hand but he denied. After prolong interrogation, he admitted that there is Ganja in Nylon Bags which is carrying by him. Then I gave him option that whether he wanted to be searched in presence and supervision of Executive Magistrate or Police Gazetted Officer. He agreed to be searched in presence of police Gazetted Officer. Accordingly, I served the Notice in writing and as per provision of law to him which he duly acknowledged by receiving and signing in the copy of Notice. Accordingly, I informed Sri. Manabendu Sekhar Rakshit, WBPS, ACP-Traffic (HQ), SPC rewarding the apprehension of said person with said to be Ganja and requested him through messenger to come at near Nawapara More, NJP and remain present as Gazetted Officer during the time of search and seizure if any which he duly accepted. At 09.15 hrs, Sri. Manabendu Sekhar Rakshit, WBPS, ACP-Traffic (HO), SPC arrived at the spot in uniform and disclosed his identity to the detained person as well as witnesses as a Gazetted Officer, Sri. Manabendu Sekhar Rakshit, WBPS, ACP-Traffic (HQ), SPC I also offered the independent witnesses and the accused person to search me and our Police Party as per provision of law.
