Sir,

With due respect, I am producing herewith the arrested accused person namely Dulal Roy (58 yrs) S/O late Bhogchan Roy of IOC Gate, Sahid Colony, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 27 (Twenty Seven) bottles of 60 up Himalayan Gold Country Spirit containing 600 ml in each bottle of MRP Rs 100/- of each bottle.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 16.07.21 at 21.55 hrs I received a secret source information that one person namely Dulal Roy of Sahid Colony Haran is selling ID liquor illegally at his shop at IOC Gate under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, diarized the fact in the General diary vide NJP PS GDE No 863 dated 16.07.21 and informed the fact to you. As per your kind direction and instruction myself along with ASI Sajal Das. C/1053 Paresw Rava, CV/306 Bisawajit Roy & CV/116 Rohit Mahato left for IOC Gate, NJP to work out the information in hand. At about 22.15 hrs we arrived at IOC Gate, NJP and being shown and identified by the source we held raid at the shop of Dulal Roy at IOC Gate and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his residence since long for his wrongful gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor found at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search, seizure & arrest was made in between 22.25 hrs to 22.55 hrs on 16.07.21.

Under the above noted fact and circumstances, I therefore pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Dulal Roy (58 yrs) S/O late Bhogchan Roy of IOC Gate, Sahid Colony, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
