With due respect I Cicilia Kujur Transit Monitoring Staff TINY HANDS INDIA Siliguri this is to bring your knowledge that today, On 15/7/2021 (time) at 2pm a four ladies has been recovered from Siliguri Tenzing Norghay Bus Terminus, Siliguri Junction through our stakeholder. As they were found in much suspected manner, when they came to get ticket for Kolkata. After the message received, we immediately reached the location in order to find the fact. But due to crowd they didn't respond us so we took them to our office for further interrogation.

During the interrogation it turns out those three ladies originally from Bangladesh, But one lady from India south 24 Pargans West Bengal name Janera Sha, as the statement they made, on 13th July 2021 all of them they crossed the border at night by river with the help of an agent and they were also handed Indian fake adhaar card. After crossing border they hold one day near Indian Border. On 14th July they again travelled to siliguri through bus with the help of agent and here in Siliguri Lady Name Janera Sha came to receive them in order to take them till Malda, again there will be another agent who will take them to kolkatta.

Therefore, after viewing this we came to the point in regard of their safety and protection, because they have illegally crossed the border, and we also assumed that this might be trafficking or will get trafficked. Therefore here, we are lodging G.D.E in favour of these ladies and you are requested to do further investigation with concern authorities and make all proper procedure to send them back to their country safely.
