

Sir,

I PSI Chetan Dangal of Pradhannagar Police Station, SPC would like to lodge a written complaint against One (01) arrested accused person named Shankar Sharma (40) S/O Lt. Tulshi Sharma of near Mallaguri Primary School,Ps Pradhan Nagar,Dist- Darjeeling for contravening the norms of NDPS Act and also would like to produce before you with following seized articles—as per seizure list:

i) 60 grams of Brown Sugar, which marked as Exhibit-A,

ii) 10 grams of Brown Sugar taken out from Exhibit A , as sample for examination and marked as Exhibit A1

iii) One Samsung mobile hand set having IMEI-1:354481112816610/01, IMEI-2: 354482112816618/01 with sim card phone connection no . 8768689050.

The brief fact is that on 16.07.21 at 18:05 hrs myself received a secret source information that one person named Shankar Sharma carrying huge quantities of brown sugar in his possession and he will come within a short time for sell the same to his designed customer at Mallaguri , Pradhan Nagar area . Wasting no time I diarized the information in Pradhan Nagar Ps General diary vide GDE No. 1029 Dt. 16.07.2021 and informed the tip off information to you for kind instruction. On being directed , myself along with PSI. Kalyan Saha .ASI. Debasish Das ,ASI Ratan Pradhan, ASI Ashit Kr Singh , CV 131 Ranjan Sharma, CV 646 Baban Das , CV/645 Pankaj Gupta left the PS at 18:10hrs vide PDN PS GDE No. 1030 dtd.16.07.21 & Vide M.C.C no. 1351 dtd.16.07.21 for perusing the information along with the I.O. Kits including Weighing machine ,etc. This is to note here that there was no enough time to obtain search warrant and there was a chance to miss the information, hence I did not obtained any search warrant.

While going to Mallaguri under Pradhannagar PS I contacted with two persons namely 1) Chand Sharma(18) S/O Safil Sharma of Ratanlal Busty, Ward no. 1,Ps.Pradhan Nagar,Dist-Dig & 2) Santosh Mahato (32) S/O Lt. Janak Mahato of Ratanlal Busty,Ward no.1,Ps.Pradhan Nagar,Dist-Darjeeling and make them aware of the information in hand and requested them to act as witness if any search and seizure would be made necessary upon which they agreed.

We reached at Mallaguri at about 18:35hrs subsequently both witness also reached there . Thereafter we along with the independent witnesses started waiting, after a while at 18:45 hrs the source pointed towards a person who was coming from Darjeeling more Side . we cordoned the said person from all sides to avoid any chance of his escape. Thereafter we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. As the person trying to hide some article infront of Police there was strong reason to believe that the article is very much suspicious and it is brown sugar. Thereafter, I gave him the option to be searched before a Magistrate or a Gazetted Officer upon which he agreed to be searched before a

gazetted officer and I gave him the option in written & read it out and after heard this he agreed and put his signature.

Then, I contacted with Sri Subasish Chaki, I/C Pradhannagar PS and requested him to come in the spot to act as a gazette officer and supervise the entire process of search and seizure. Sri Subasish Chaki,I/C PS arrived at the spot at 18:55hrs and thereafter the process of the search was conducted. Before conducting the search self search of mine and Sri Subasish Chaki,I/C PS had been conducted by the detained person named Shankar Sharma and a memo had been given to him to the effect. On being searched from his possession one Plastic Packet containing Brown Sugar in the left pocket and one Samsung mobile phone in the right pocket has been recovered. .

Thereafter, I started weighting the Packet of brown sugar with a weighing machine kept with us for the purpose of weighing and on weighing the quantity of the recovered Brown Sugar turned out to be 60 grams. Accordingly, I seized the recovered Brown Sugar total weighing 60 grams, one Samsung mobile phone in-between 19:10 hrs to 19:40 hrs by preparing a seizure list duly signed by the accused person, independent witnesses. In the seizure list I obtained the signature of Sri Subasish Chaki ,I/C Pradhannagar PS ,SPC and put my signature too. The seized mother packet of Brown Sugar had been labeled as Ex - A and I also took sample from the mother packets 10 grms Broun Sugar and Labeled marked as Ex-A1. The apprehended accused Shankar Sharma (40) S/O Lt. Tulshi Sharma of near Mallaguri Primary School, Ps Pradhan Nagar, Dist-Darjeeling had been arrested by me at 19:50 hrs by issuing a proper Arrest Memo for contravening the norms of NDPS Act, on interrogation he stated that he purchased the Broun Sugar from Kalia Chak ,Malda for selling at Siliguri area to obtain huge profit .Then we returned back to PS. taking the accused & seized article.

In the above circumstance, I pray before you to take charge the seized articles and also to start a specific case against Shankar Sharma (40) S/O Lt. Tulshi Sharma of near Mallaguri Primary School,Ps Pradhan Nagar, Dist-Darjeeling and others under proper section of law and arrange for investigation.
