

In producing herewith one arrested accused person namely Ashok Kumar Sah (30) s/o Rajendar Sah o of Mallaguri near Gupta Restaurants and Bar PS- Pradhannagar, Dist- Darjeeling seized articles viz (i) 11 (Eleven) bottles of Himalayan Gold country Spirit each bottle containing 600 ml out of which one bollte Himalayan Gold country Spirit was taken as sample for examination and marked as exhibit "A" and "A-I", (ii) 09(Nine) bottles Imperial Blue each bottle containing 180ml out of which one bottles of Imperial Blue was taken as sample for examination and marked as exhibit "B" and "B-I", as per the seizure list (which is enclosed herewith), I ASI. Ratan Pradhan of Pradhannagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against one the above noted accused person to the effect that on 16.07.21 in course of special raid duty at 22:30 hrs received a secret source information that one person illegally selling liquor inside his shop namely Shivam Hotel situated at Mallaguri near Gupta Restudent and Bar under PS Praddhannagar, Dist- Darjeeling without any valid license.

Accordingly I informed the matter to I/C Pradhannagar PS, SPC and as per kind direction myself along with ASI Ashit Kr. Singh, ASI Debasish Das ,cv 131 Ranjan Sharma left for the spot by govt vehicle to verify the veracity of source information. On reaching there I tried to search disinterested witnesses but due to lock down no body found available there. On being identified by the source, it was found that the mentioned person was selling liquor inside his Shop namely Suman Hotel to the customers. On seeing our team the customers and shop owner tried to flee away leaving the liquors which was selling to the customers. But police team managed to apprehend the above noted person. On being asked to the apprehend person it came to learnt that the he is owner of his house cum shop. He during lock down collected the above liquor from heather and thither for the purpose of selling to the common customers in high price at that house since long for his wrongful gain without any valid paper. Accordingly, in the very presence of above noted witnesses conducted search of the said house cum shop and above noted liquors were recovered. Accordingly I seized the liquors from the house cum shop of accused person under proper seizure list duly signed by the witnesses. Seizure was made on 16.07.2021 between 22.45 hrs to 23.55 hrs. Then I, labelled the seized articles duly signed by the witnesses as well as apprehend person. On Examination it came to lernt that the house cum shop owner involved for running this illegal business of liquor at the said house cum shop under cover of darkness during lock down period without any license or permission from the appropriate authority in the close vicinity of Public Place.

Hence I request you to start a specific case under proper section of Bengal Excise Act- 1909 as amended till date against the arrested accused Ashok Kumar Sah (30) s/o Rajendar Sah o of Mallaguri near Gupta Restudent and Bar PS- Pradhannagar, Dist- Darjeeling and kindly arrange for its investigation.
