With due respect, I SI Mijanur Rahaman of Bagdogra PS, do hereby lodge this written complaint against the following arrested persons namely i) Soumen Singha 18yrs s/o Uttam Singha of Gosainpur Mulaijote PS, Bagdogra Dist, Darjeeling ii) Sushil Chowdhury 42yrs s/o Late Ram Balak Chowdhury of Bhujiapani Kolkata Road PS, Bagdogra Dist, Darjeeling iii) Arindam Bala 18yrs s/o Hangsho Bala of Gosainpur Mulaijote PS, Bagdogra Dist, Darjeeling iv) Placidious Barla 50yrs s/o Late Libnus Barla of Kolkata Road Bhujiapani PS, Bagdogra Dist, Darjeeling for disobeying Government order vide Memo no 486/CS/2021 dated 24.04.2021 and order No 647-15S/2M-22/2020 dated 15.05.2021.

The facts of the case in brief is that today on 17/07/2021 at about 13.15 hrs in course of K-35 Morning van duty vide Bagdogra PS GDE No 934 Dated 17/07/2021 the above noted persons were roaming unnecessary at Bihar more, ti-junction area also they did not were face mask as the Government of West Bengal has issued various order vide Memo no 486/CS/2021 dated 24.04.2021 that wearing of facial mask and maintain social distance made mandatory in public places in the current pandemic disaster situation all persons are to strictly comply with the COVID-19 safety norms in effect from 6 AM Sunday 16th May to shall remain 6 PM 15th June 2021 vide order No 647-ISS/2M-22/2020 dated 15.05.2021 in terms of the provisions under Disaster Management Act 2005 read with West Bengal Epidemic Disease, Covid-19 Regulations 2020 unnecessary movement shall be strictly prohibited. Accordingly, I stop them and ask to reason for not wear of face mask and roaming unnecessary but they could not give any satisfactory reason also violate against our police party. It is pertinent to note here that since the outbreak of Second wave of Corona Virus awareness regarding wearing of face mask and maintain of social distancing had been conducted through miking but the above noted persons had no botheration regarding their own safety and also the safety of others. Their act is dangerous so as to the spread of Corona Virus. Thereafter, I tried to convince them and directed to wear face mask but they denied to do so and started arguing with me. Finding no other alternative way, I apprehended them to avoid risks to human life and health.

Under the above facts and circumstances, I request you that a specific case against the aforementioned persons may kindly started with suitable sections of law.
